Joel Palmer phone call this a.m., ending about midday.-noon/

The ostensible purpose of the call was to ask if I knew what evidence besides Russo Garrison had on Shaw. I told him I had never asked, never seen, and assumed he had more, as I had written in O in NO.

We got into the Perrin-Rich-Boxley matter and he said, in effect, that this had been Garrison's idea, with him even going to the Kittie's home, etc. that he was with Boxley and B's reports were accurate, that he hadn't said more to me when I had questioned him because he felt under obligation (no longer) to Garrison. He had just been in Tampa on the Hoffman matter when this happened.

He says Garrison was about to make further charges against Bradley when it happened, with the release all written, over his and Boxley's objection, as I recall. Several times he said Garrison was disgusted with his staff and their attitude and was about to do something.

On Shaw, he said he is surprised they didn't use what they had from Voebel, apparently a phoned interview with Alcock, about a dinner party he had attended that was so degenerate he left. Ferris and Shaw both at it.

Nancy believes her husband murdered. He could not say how this squared with Perrin being seen by four witnesses two minutes from Pealey Plaza.
