

The alleged CIA plot to ~~kill Garrison~~ mislead Garrison is Garrison's false explanations of why he did not charge Robert Perrin and Edgard Eugene Bradley with having been Grassy Knoll assassins and why he fired the man now dead who had used the name Bill Boxley because under his right name, William Wood, he had been fired by the CIA for drunkenness. Garrison hired ^{him} ~~in~~ in May, 1967, over staff objections, and paid him from private funds contributed to his "probe."

The fact is that when his staff had failed to dissuade Garrison from this self-invented atrocity that would have meant an additional ^{w/} national disgrace, ^{w/} too of his staff, the chief investigator and the assistant district attorney closest to Garrison, enlisted Weisberg's aid in aborting and preventing it. They provided what few memoranda Boxley handed in (mostly he reported to Garrison verbally and in private) and conducted for Weisberg ^{those} investigations he requested. ^{see} This included proof that Perrin had in fact committed suicide in 1962.

Confronted with Weisberg's report Garrison fired Boxley and issued a press release alleging that Boxley had been infiltrated onto his ~~staff~~ staff to lead him astray.

(In the original script Stone further disguises Garrison's personal responsibility for Boxley by ~~ga~~ falsely presenting him as an assistant district attorney when Garrison began his "probe".)

Weisberg has a carbon copy of his report, which begins by stating baldly that Boxley was "feeding back" to Garrison "evidence" he made up because he knew it was what Garrison wanted, and enough of the documents ignored in the Garrison/Boxley "investigation" to establish that Perrin had killed himself and that it was not the corpse of a Venezuelan ~~seaman~~ seaman as Garrison/Boxley claimed. He also had the confirming memo of the assistant district attorney who ~~asked him to try to prevent~~ asked him to try to prevent what Garrison was up to.

The charge against Bradley, the west-coast representative of the Cape May, New Jersey extremist preacher, Rev. ~~Carl~~ Carl McIntire, was based on the alleged identification of him in unpublished Dallas newspaper photographs taken the day of the assassination. Garrison and his ^{claque} of like-minded conspiracy inventors decided that these men were disguised

as tramps but were actually conspirators. Bradley was merely the first of an incredible series of "identification" that included even two Watergaters, E. Howard Hunt and "rank Sturgis. When Garrison could no longer avoid the fact that they were not at the scene of the crime and this could not have been assassins, the ^{ir} role was switched to that of "paymasters."

9 On learning that ~~these~~ that the invented "identification" of Bradley was to be used as the sole basis for ^{char} charging him as an assassin, Weisberg caused two professional and completely independent investigations to be made, neither knowing of the other. One was by his friend, Henry Wade, then Dallas District Attorney, who sent a staff professional ^{police} investigator to do it, and the other by Paul M. Rothermel III, then chief of security for Oil Magnate H.L. Hunt. Wade and Rothermel are former FBI special agents. Each actual investigation established that the men were winos, drunk in a park railway boxcar behind the General Annex Post Office and picked up by the police the the course of the search of the entire area - ^{a block west of the scene and two and a half blocks west of it} an hour and a half after the shooting. They were near the Texas School Book Depository building, where news photographers ~~were~~ were photographing everything that moved, because it was the only way of walking them off the railroad tracks.

The most cursory ~~ex~~ glance at these "tramp" pictures reveals that the ~~police~~ ^{suspects} were not at all worried about them. Not one was handcuffed and ~~none of the other policemen~~ the two policemen and a ^{deputy} sheriff do not even have a pistol drawn.

In response to this exposure Stone insists, without even suggesting that he has an evidence to support it, that the men were arrested "behind" that building and it was only "25-30" minutes after the shooting. Weisberg has an FBI report disclosed to him later in reaction to another investigation he caused confirming the results of the investigations made for him.

If Stone, a legitimate photography expert, had examined these pictures at all he could not avoid the fact that the ^{shadows} shadows along ~~disprove~~ ^{in court} disprove his ~~fabricated~~ timing, that is based on a ~~casual error by a policeman not involved in the matter.~~

If Stone had not decided not to accept Weisberg's offer of free and unsupervised access to all the records he got by FOIA lawsuits he would have had the FBI report telling the truth about those winos. It is based on interviews with the two policeman and that deputy sheriff.
