DALLAS NOV.30 (AP)-THE MOTHER OF LEE HARVEY OSWALD CLAIMED TODAY THAT AN FBI AGENT "SHOWED HER A PICTURE OF JACK RUBY THE NIGHT BEFORE HER SON WAS SLAIN. AN FBI AGENT FLATLY DENIED THE STORY.

OSWALD, 24, ACCUSED SLAYER OF PRESIDENT JOHN F. KENNEDY, WAS SHOT TO DEATH BY RUBY IN THE DALLAS CITY JAIL.

EDDIE HUGHES OF THE DALLAS NEWS IN AN INTERVIEW WITH MRS. MARGUER OSWALD SAID THE ACCUSED ASSASSINATOR'S MOTHER EXPRESSED BITTERNESS TODAY TOWARD THE FBI AND SAID THAT AN FBI MAN HAD SHOWN HER A PICTURE OF RUBY ON THE EVE OF HER SON'S DEATH.

"THE FBI KNEW SOMETHING. HOW THEN DID HE (RUBY) MANAGED TO GET SO CLOSE TO MY BOY IF THE FBI FEARED THIS MAN MIGHT DO HARM?" SHE ASKED.

HUGHES SAID AN FBI AGENT FLATLY DENIED HER STATEMENT. HE QUOTED THE AGENT AS SAYING HE HAD SHOWN THE MOTHER A PICTURE AND ASKED HER IF SHE KNEW THE MAN PORTRAYED IN IT. THE AGENT SAID THE MAN WAS NOT RUBY.

IN ANOTHER DEVELOPMENT, MRS. RUTH PAINE, WITH WHOM OSWALD'S WIFE AND TWO CHILDREN LIVED, TOLD OF THEIR LIFE FROM THE END OF LAST SUMMER UNTIL AFTER THE ASSASSINATION.

MRS. PAINE SAID OSWALD'S SECOND BABY COST HIM NOTHING. BECAUSE OF HIS LACK OF INCOME, HIS WIFE, MARINA, 22, WAS ELIGIBLE FOR FREE DALLAS COUNTY MEDICAL CARE, SHE SAID.

MRS. PAINE SAID OSWALD "WAS CONCERNED ABOUT BEING ABLE TO TAKE CARE OF THE BABY." SHE ADDED:

"HE NEVER ASKED ME FOR MONEY," MRS. PAINE SAID OF OSWALD. BUT HE NEVER CONTRIBUTED TO HIS WIFE'S SUPPORT DURING HER IRVING STAY, EXCEPT TO DONATE \$10 FOR A PAIR OF SHOES.

"I DIDN'T MIND, " SAID MRS. PAINE. "I KNEW THEY WERE TRYING TO SAVE ENOUGH MONEY TO GET AN APARTMENT TOGETHER AGAIN AFTER CHRISTMAS."

MRS. PAINE SAID THAT OSWALD HITCHHIKED FROM THE DALLAS BUS STATION TO THE PAINE HOME IN SUBURBAN IRVING WHEN HE RETURNED TO TEXAS THIS FALL. SHE SAID "HE MAY WELL HAVE HITCHHIKED TO LAREDO, AND BOUGHT A BUS TICKET TO MEXICO CITY FROM THERE."

"IT'S ENTIRE POSSIBLE THAT HE RECEIVED UNEMPLOYMENT CHECKS FROM TEXAS THE WHOLE TIME HE WAS WORKING IN NEW ORLEANS," SHE ADDED. OSWALD RECEIVED HIS LAST STATE UNEMPLOYMENT CHECK THE WEEK BEFORE HIS BABY WAS BORN, AND ALMOST IMMEDIATELY OBTAINED A LOW-PAYING JOB WITH THE TEXAS BOOK DEPOSITORY.

BEFORE OSWALD DRIFTED TO NEW ORLEANS LAST MAY, AND LATER BACK TO TEXAS, APPARENTLY BY WAY OF MEXICO, HE AND HIS WIFE HAD BEEN LIVING IN A FURNISHED APARTMENT FOR ABOUT \$65 A MONTH.

"MARINA TOLD ME THEY WERE USED TO LIVING ON \$200 A MONTH, MRS. PAINE RELATED, "AND LESS WHEN THEY WERE PAYING BACK THE LOAN WHICH BROUGHT THEM BACK TO THE UNITED STATES FROM RUSSIA."
