

Karmazin, Michael Assistant District Attorney, first mention. Files bill of exception when Judge O'Hara dismisses public bribery indictment against Steve Plotkin and Sanford Krasnoff. *New Orleans States-Item*, 1/22/69

Karno, Nick 5230 Camp St., New Orleans. Among 18 state witnesses subpoenaed for the Andrews trial beginning 8/9/67. *New Orleans States-Item*, 8/1/67

Kaskell, Ralph L. Attorney for *Maryland National Insurance Company*. He charged District Attorney's office allowed bond forfeiture judgments against *Maryland* to reach \$1,040,000 before taking action to collect. Makes claim in federal court where District Attorney's office seeks dismissal of a *Maryland* suit seeking restraint on state from seizing its assets. Judge Lansing L. Mitchell continues hearing until later date, extending a temporary restraining order against state and District Attorney from seizing the assets. District Attorney's office claims matter still unsettled in state courts and feds therefore lack jurisdiction. Briefs to be filed by 8/22. *New Orleans States-Item*, 7/1/69

Kellerman, Roy Secret Service officer who was riding in front seat of JFK car 11/22/63. Subpoenaed by state as Shaw trial witness. *New Orleans States-Item*, 1/16/69

After Justice Department files a consent order, Maryland Circuit Judge orders Kellerman to testify for State at Shaw trial. *New Orleans States-Item AP*, 1/29/69

UPI describes him as now an FBI agent after serving in the Secret Service. *San Francisco Chronicle*, 1/30/69

Kaye, Connie T. Identified as a singer, of 711 Royal, New Orleans., who said she was questioned earlier by District Attorney's office after she revealed she had had a run-in with Oswald in 1963 when he objected to some Cuban material in her night club act.

Keating, Lionel, Patrolman Accidentally shoots self in hand in District Attorney's outer office while shedding his gun and holster just before going into court to testify. *New Orleans States-Item*, 3/6/70

Kelley, Walter D. Attorney who, with John P. Dowling and Lilliam M. Cohen, appeared before Judge Shea as fourth set of attorneys for Dean Adams Andrews, asked for transcript of his trial, grand jury appearances and statements he made to District Attorney and staff. Said they were appearing without compensation. *New Orleans States-Item*, 9/8/67

Kemp, Jim Television newsman (station not named). APA7GNU 221 to 456 pcs, 3/15/67

Now described as a television announcer, address 1418 Cleveland, subpoenaed by Shaw defense as witness in Shaw trial. *New Orleans States-Item*, 1/16/69

Kemp, Maxine, Mrs. Testified for state that she was personnel officer's secretary at *East Louisiana State Hospital* where she saw a job application with Oswald's name on it, but that after the District Attorney's investigation began she could not find it. *New Orleans States-Item*, 2/7/69

Kennedy, Edward M. (Ted), Senator Democratic senator from Massachusetts. After RFK's burial in Washington Archbishop Philip M. Hannan of New Orleans returns saying friends are urging Ted to withdraw from political life. *New Orleans States-Item*, 6/10/68

Breaking a 10-weeks silence, calls for an unconditional halt to bombing in North Vietnam. *New Orleans States-Item*, 1/3/69

Says he won't run for office this year but to those who have advised him to retire for safety's sake he says "there is no safety in hiding." *AP A240bx 441 ped*, 8/21/68 [filed EMK]

See his personal file under Kennedy family. Defeats Sen. Russell Long for Senate Democratic whip. *New Orleans States-Item*, 1/3/69

Receives death threat, no details; police patrol around his home at Fairfax, VA. Aide says "similar things have happened before." *AP* A085wx 1048aes [filed kenfam-emk], 1/18/69

Drops many humorous hints at Washington fund-raising dinner that he could be persuaded to run for president in 1972. *San Francisco Examiner AP* [kenfam-emk], 1/23/69

Accident on Chappaquiddick Island involving the death of Mary Jo Kopechne, et seq., 7/19/69 [See EMK-b file]

Kennedy, Regis

FBI agent, New Orleans, who with then agent Warren deBrueys questioned several people there in 1963 about Oswald.

Subpoenaed by grand jury 5/10/67 to testify in Garrison probe, along with deBrueys, Carlos Quiroga, and truck salesman Oscar desSlatte. U.S. attorney Louis LaCour moved that Judge Ben Bagert quash the subpoena because FBI men traditionally do not testify before state grand juries. LaCour said Kennedy had been ordered not to testify by U.S. Attorney General Ramsey Clark. Hearing on motion set for May 16. Garrison said feds, by refusing to testify, "obviously" were taking the 5th Amendment. *AP* 10may67 143pcd Picture

Ibid: Cuban sources in New Orleans said they remember both Kennedy and deBrueys had attended meetings of anti-Castro groups organized in 1961.

Among 18 state witnesses subpoenaed by District Attorney for Andrews trial beginning 8/9/67. *New Orleans States-Item*, 8/1/67

Government advisors to the *Friends of Democratic Cuba*, (incorporated 1/9/61) says an informant who was closely involved with the group, were a CIA man named Logan and the FBI's Regis Kennedy. ... *Ramparts*, 1/68, p. 53 William W. Turner.

Subpoenaed by state as witness against Shaw. *New Orleans States-Item*, 1/13/69

Testifies as state witness at Shaw trial. Confirms he interviewed Dean Andrews re: Clay Bertrand after Andrews called him twice from the hospital. Demurs when asked if he already was investigating the JFK assassination when Andrews called him. Accompanied by U.S. Attorney. Harry Connick, who offers to call Washington to get permission. When it reportedly is obtained, Kennedy answers that he was already investigating the assassination when Andrews called him, and was looking for Bertrand. Examined by Dymond, says he didn't find Bertrand.

Kennedy says he retired last 5/31 after 30 years. *New Orleans States-Item*, [& proceedings], 2/17/69

Penn Jones account of this question and answer sequence, showing Alcock did not go on and ask how Kennedy learned about Bertrand in the first place. *Midlothian Mirror* [filed magazines], 3/27/69

Kennedy, Robert F., Senator, (D-NY) See William Gurvich 6/8 for half an hour, then rides with him to airport and talked some more. *Newsday* says Kennedy "extremely grateful." Gurvich defected 6/23/67 from Garrison probe. *New Orleans States-Item*, 6/23/67, *New York Times*, 6/24/67

Walter Sheridan, now of *NBC*, served as an investigator for the Senate Rackets Committee and as an official of the U.S. Department of Justice. He worked for Robert F. Kennedy in both positions. *New Orleans States-Item*, 7/13/67

Terence O'Flaherty: From New York comes the official reason for *NBC*'s hasty scheduling of its report on the Garrison investigation. The news department had every assurance that Garrison's aide would defect from the New Orleans district attorney's conspiracy hunt. On 1/5/68 National Archives makes public text of agreement between Kennedy family and Archives regarding JFK's clothing and autopsy photos and X-rays. Wording suggests these actually being turned over, but says actually only

that "all right, title and interests" are being transferred. *New York Times*, 1/6/68

RFK's chances in Louisiana. Similarities between his situation and that of JFK in 1960. *New Orleans States-Item*, Bill Lynch column, 3/23/68

New Orleans States-Item, Baton Rouge man Bill Lynch says RFK has asked McKeithen to prevent District Attorney from subpoenaing him when he campaigns in New Orleans. No such plans, District Attorney's office says. Story recalls RFK's statement recently in CA that he would not reopen the investigation if elected. *New Orleans States-Item*, 3/29/68

Campaigning in southern CA, Kennedy says he would reopen the Warren Report, has seen everything that's in it, etc. Various version this date, also TAPE # 79, 3/25/68

Mark Lane article, "Is Bobby Silent Because (the CIA) Killed His Brother?" Lane appears to credit the Drew Pearson story about the CIA-hatched plot against Castro bouncing against JFK while Bobby had nominal charge, that even one man assigned to the Castro job was aced against JFK. Appears to think Bobby continues to hold to the Warren Report because of fear that LBJ or the CIA will tell all. (In talk at *Contra Costa College*, 5/7/68 Lane says Jack Anderson said the yarn came from the CIA). *LA Free Press*, 4/19/68

Mark Lane, in talk at *Contra Costa College*, says Jack Anderson told someone in the Senate that the Drew Pearson column about the CIA plot to kill Castro came from a CIA official, ostensibly as a signal that the CIA was not

afraid to release basic facts as well. Notes 5/7/69

Lane says Bobby requires TV and radio stations to promise not to ask him any questions on the Warren Report, the Garrison probe, or Lane's book, before granting interview. Owen Spann confirms re: *KGO*. Notes 5/7/68, *LA Free Press*, 4/19/68

Assassinated just before midnight the morning of 6/5. Just after it became apparent he had won the California primary election, just after making victory speech at *Ambassador Hotel* in Los Angeles.

Suspect, Sirhan Beshara Sirhan, seized at scene with pistol in hand.

RFK died roughly 25 hours later, early morning of 6/6. See separate files, RFK and Sirhan.

Mark Lane says that for several weeks before his death RFK had been in touch with District Attorney, through two emissaries who said he did not believe the Warren Report and that if elected he would investigate. When District Attorney said he'd be safer if his real beliefs were made public the reply was that "there are guns between him and the White House; District Attorney said his life more endangered by silence. Lane says minutes after his election victory was assured in California he was executed. *LA Free Press*, 6/21/68

[Saw private correspondence indicating one emissary was Jones Harris of New York, the other named Lind.]

Joseph Lewis, 37, died 9/68(?), following two days of high fever attributed to virus infection; cause of death officially still undetermined at time this note was made. Lewis - former *AP*, *LA Times* and *Time* magazine reporter and writer -- had recently been commissioned by *McGraw Hill* to collaborate with chief detective of LA police department on book about RFK assassination. Private source; [Filed RFK.], 11/31/68

Gerald Mohr, died 11/10/68, Stockholm; cause of death not given. Bill Turner says Mohr told him prior to leaving for Europe that when he returned he was "really going to get to work" on the assassination, presumably that of RFK. Had been just in front of RFK at *Ambassador Hotel* when he was shot. *New York Times*, [Filed RFK.], 11/11/68

RFK's assassination in historical perspective with that of JFK, suggesting parallelisms in cause and effect if not method. Letter suggests RFK may have been necessary to prevent disclosure re: JFK's death. *Minority of One*, 11/68

Senator McCarthy says RFK broke promise not to oppose him for Democratic nomination, and that if he hadn't he'd probably still be alive. *New York Times*, 1/9/69

Hoffa's Plot to kill Robert F. Kennedy by Clark R. Mollenhoff, *Argosy*, 7/69

Kevin, Art

KHJ radio, Los Angeles. Interview with District Attorney brings out District Attorney's contacts with RFK and

District Attorney's belief the same power was responsible for all three assassinations, that anyone trying to stop the cold war will be assassinated by another "lone assassin." *New Orleans States-Item*, 7/3/68

In article on coverage of the trial, two who were there discuss Kevin's pro-Garrison stance, but note Jim Phelan was even more pro-Shaw and Hugh Aynesworth still more so, with both working openly to help destroy District Attorney's case. *Columbia Journalism Review*, Spring 1969 (April) [Filed magazines]

Khrushovski, Abraham, Rev. Named as landlord who rented apartment to Robert Lee Perrin and wife in 1963 under mysterious circumstances and where Perrin allegedly committed suicide. *Midlothian Mirror* [magazines], 1/30/69

Kihnell, Larry Identified as Jefferson Parish sheriff's detective and undercover man who infiltrated SDS. Lectures *INCA* ladies' *Guild* on evils of Communism and the way it leads student dissent groups around by the nose. *New Orleans States-Item*, 7/17/69

Killam, Earl Brother of Thomas Killam, the Dallas house painter whose partner, Jack Carter, had once lived at same rooming house with Oswald, married a Ruby stripper, and was found dead in Pensacola, FL, amidst shattered plate glass window 3/17/64, police called suicide. Earl asked authorities to exhume body to find exact cause of death. *AP* A84nu et sq 422pcs 22feb67

Killam, Thomas Dallas house painter who married a Ruby stripper and whose partner, Jack Carter, once lived in same boarding house with Oswald, found dead Pensacola Florida 3/17/64 in midst of shattered plate glass window. Police listed suicide. had. had a mysterious phone call at 4 a.m.. Brother Earl Killam asked authorities to exhume body to determine exact cause of death. *AP* A84 et seq 422pcs 22feb67

Kimble, Jules Rocco Death and Terror Wear *Klan* Hood, by Hoke May. Describes Kimble, 24, as a young man who says he's a double agent between the *Klan* in New Orleans area and state police. Estimates 600 to 800 members in New Orleans area. Takes author to visit rural house where fiery crosses being made. Talks of guns, bombings and plans to kill civil rights leaders. Has police record for aggravated assault, false impersonation and carrying concealed weapon. *New Orleans States-Item*, (2 stories), 9/8/67

Described as former *Ku Klux Klan* official. Of New Orleans. testified before East Baton Rouge Parish grand jury 10/11/67. *New Orleans States-Item*, 10/12/67

Kimble was taken to Baton Rouge from New Orleans where he had been in parish prison under \$5,000 bond on a charge of impersonating a state police officer. *New Orleans States-Item*, 10/11/67

Said to be a self-avowed member of the *Ku Klux Klan* who got into trouble over bombings in Baton Rouge, approached Garrison's men in hopes of gaining mitigation. Said the day after Ferrie died, he drove Jack Helm, a top KKK official, to Ferrie's apartment where Helm came out with a satchel crammed with papers which were put in a bank safe deposit box; said in 1962 he had flown to Montreal with Ferrie on purported *Minutemen* business. Then he broke contact, called his wife from Montreal, wound up in Tampa where police arrested him. Told District Attorney's men he went to Montreal after Walter Sheridan advised him to clam up and go to Canada where he made contact with CIA. *Ramparts*, 1/68, p. 68, William W. Turner

Allen-Scott (columnists) say Kimble claims he once worked special assignments for CIA. CIA denies it, but Garrison says he'll prove it. *Human Events*, 1/20/68

Kirkwood, James

Described as novelist; author of sympathetic article on Shaw in 12/68, *Esquire* which assumes Shaw's complete innocence and bewilderment that he should be charged with plotting JFK assassination. *Oakland Tribune UPI*, 11/10/68

Farther was James Kirkwood, Sr., mother actress Lila Lee. Has written new novel *Good Times, Bad Times*, which made alternate book of the month club choice and has been sold to the movies. Concerns prep school murder of a headmaster. Kirkwood covers the trial for *Playboy* and has a commitment from *Simon and Schuster* to expand it into a book if the testimony warrants. *New Orleans States-Item*, Lagniappe, 2/12/69

Review of Kirkwood's novel, *Good Times/Bad Times*, an account of prep school life with homosexual theme, including a murder. *Saturday Review*

"Most passionately pro-Shaw was James Kirkwood..."

Acquitted (both) on all counts 6/23/67. No mention of Kroman. *New York Times*, 6/24/67

Klein, Burton

Attorney for Alvin Beauboeuf, charges District Attorney office tried to bribe and threaten client into testifying to a conspiracy. District Attorney office says did offer to help him, but only trying to get the truth. District Attorney produces affidavit signed by Beauboeuf upholding District Attorney version. Klein claims has a tape recording of the alleged threat and bribe try. Affidavit says he tried to sell it to national magazine (unnamed). *AP* 10may67 817pcs & *New York Times* same date.

Garrison charges both Klein and Plotkin (Novel's attorney) being paid by CIA. Both deny it. Says Klein recently went of Washington, Klein says "no basis in fact" for saying he contacted CIA. *AP* 11may67 944pcd

Klein says Beauboeuf lie detector test shows Beauboeuf telling the truth when said he threatened and bribery attempt made. Declines to say where test made. Beauboeuf told newsmen 5/8/67 he going to Washington 5/9/67 to take one. *New York Times*, 5/11/67

Photo of Klein and Beauboeuf, *New Orleans States-Item*, 5/10/67

Appears as attorney for Miguel Torres, moving to stay Torres' appearance before grand jury because Torres fears self-incrimination and possible charges by District Attorney in connection with *NBC* program. Asks stay until federal court rules on Sheridan grand jury appearance. *New Orleans States-Item*, 8/17/67

Torres returned on habeas corpus write to testify. Klein moved to prevent his testifying; Judge Bagert overruled. *New Orleans States-Item*, 8/23/67

Subpoenaed by New Orleans Grand Jury, appeared but was told jury would not get to him during the day. Said he didn't know why called. Was called for same day as Carlos Marcello. *New Orleans States-Item*, 10/5/67

Klein, Frank

Former assistant District Attorney, New Orleans, listed in origins story on the investigation as having been paid \$345 by the District Attorney's office for "Special counsel" for a "special investigation." *New Orleans States-Item*, 2/17/67

Appears with Milton Brener as attorney for William Gurvich in Gurvich's trial on charge of stealing District Attorney's documents. *New Orleans States-Item*, 9/5/68

Klein, Joan Dempsey Los Angeles Municipal Judge who granted continuance to Edgar Eugene Bradley and later dismissed his fugitive warrant after Reagan refused extradition. [See Bradley] *AP* 333aes, 11/9/68

Klein, William Described as brother of an attorney (Burton Klein?) for one of the figures (Beauboeuf?) in the Garrison probe. Identified as one of the incorporators of the *Friends for Democratic Cuba*, a militant anti-Castro group formed in New Orleans in 1961 and later merged with others. See also Banister, Dalzell. *New Orleans States-Item*, 6/30/67

Kloor, Morris, Dr. 7107 Maple, New Orleans. At hearing 5/2 on motion for new trial for John Cancler, Kloor said Donnell Carroll was not the man he had seen entering a house which John Cancler had been charged with burglarizing. New trial had been asked on basis of Carroll's confession. *New Orleans States-Item*, 7/17/67

New York Times version says Kloor had told District Attorney's office he had seen Cancler and a woman enter the house and emerge with a bag and a suitcase. Cancler had admitted being in the area because he was delivering a prostitute to a nearby fraternity house. District Attorney's office says Carroll's description of the house didn't fit. *New York Times*, 6/12/67, Gene Roberts.

Knight, Nelson Student pilot, acted as guide to Garrison investigators as they checked several Dallas airports, interviewing about 30 persons. AP52dn 1037pcs 26 Feb. 1967

Knowles, Daniel D. 1615 Elmire Ave., Algiers. Subpoenaed by Shaw defense for pretrial hearing set for 9/11/67. Not further identified in story. *New Orleans States-Item*, 9/6/67

Knowles, Donald L. Douglas County attorney, Omaha, said he didn't know where Lillie Mae McMaines living. Officials indicated when papers for her arrest arrive from New Orleans she will be taken into custody. *AP* B61 940pcs, 3/28/67

Kohlman, Herman S Assistant District Attorney. *New York Times* (Nan Robertson, Washington) 2/24/67

Kohn, Aaron Director, New Orleans *Metropolitan Crime Commission*. *LA Times* (Nelson, Chriss), 2/26/67

Merriman Smith: Kohn if former FBI man who for more than 20 years has specialized in investigating police departments. Came to New Orleans in 1953 at mayor's request, has remained as managing director of the privately financed *New Orleans Metropolitan Crime Commission*. Consists largely of himself and several secretaries, board of directors includes some of the biggest names in city's banking, finance, business and education. He and Garrison have no use for each other. Garrison says "If there is organized crime in New Orleans it is in *the Metropolitan Crime Commission*."

Kohn told Smith the city had elements suffering from emotional illness, "lunatic fringe combining intelligence with distorted emotions." *LA Herald-Examiner*, 3/5/67

Director, New Orleans *Metropolitan Crime Commission*, first mentioned as deprecating Garrison's securing of a pardon for a stripper convicted of lewd dancing. "I'm amazed that a potential big leaguer could get sucked into a bush league play." *LA Times*, Nelson-Chriss, New Orleans, 2/26/67

Garrison and Kohn have no use for each other. Garrison says: "If there is any organized crime in New Orleans, it is the *Metropolitan Crime Commission*." Kohn a former FBI agent who for past 20 years has specialized in cleaning up police departments. Came to New Orleans at request of mayor to do such a job in 1953. *MCC*'s board of directors contains some of the biggest names in town, from the world of banking and finance, business and education.

Shortly after JFK killed, Kohn made report on certain aspects, mentioning lunatic fringe in New Orleans "identifiable through active evidence of destructive hate." Went no further. *LA Herald Examiner*, Merriman Smith *UPI* 3/3/67

There is no question today of Kohn approving anything Garrison does, particularly in connection with his current investigation. *San Francisco Examiner-Chronicle*, *LA Herald-Examiner*, *Long Beach Independent Press Telegram*, Merriman Smith, *UPI*. New Orleans, 3/5/67

- Kramer, Joseph** Pseudonym for Richard Case Nagell, he says with DIA authorization. *Ramparts*, 1/68, p. 58, William W. Turner
- Kremer, Daniel** California deputy attorney general who represented Garrison at Edgar Eugene Bradley extradition hearing in Sacramento. Tells Meese Bradley's attorney George Jensen was chipping away at supporting documents and not the central issue, which is whether Bradley is the man Garrison wants. Bradley says no, that Garrison is after the wrong man, that there's another Edgar Bradley. *San Francisco Examiner, New Orleans States-Item, AP SC11*, 6/26/68
- Kreutz, Andy** *WVUE*-TV reporter, subpoenaed by Shaw defense. Interviewed Alcock. *New Orleans States-Item*, 1/9/69
- Kroman, David R.** Minneapolis attorney, with four others, defendant in insurance fraud trial at Bismarck, ND.
- Found 3/27/67 partly dazed in locked rented car, shotgun across legs, off road from Minneapolis. Said had been forced off road by two cars which had been following him. He had scheduled a news conference that night to tell his story on the assassination and possibly name names. Said he had been in touch with Garrison. Another attorney, Richard E. Olson, said Kroman had had at least three previous attempts on his life, the last a week ago in Bismarck.
- Had been independent Democratic candidate for attorney general in last MN election. Hospital said he had epileptic seizure. *San Francisco Examiner 4-star UPI*, 3/27/67
- "I wasn't supposed to get here," said Kroman. Later, U.S. District Judge Edward J. Devitt severed Kroman from four other defendants and declared mistrial in his case, ordered mental examination for "45 days more or less, whatever is necessary." Kroman led out by two federal marshals en route to U.S. Medical Facility at Springfield, MO. Dr. Gerd Fischer had said Kroman's condition caused by epileptic seizure. Kroman denied it. Said he had begun investigating in 1963 after "certain statements were made by a Cuban" and that he had pursued case in Dallas, Miami, Key West, Las Vegas, New Orleans and Kansas City. *AP B58 4pcs 27mar67*

Testifying in own defense, said one car drew abreast of him and occupant pointed a pistol at him, forcing him off the road. Said was carrying documents that would tend to prove or in some cases prove that Oswald did not assassinate JFK and that others did. Judge ruled reasonable cause to doubt sanity and ordered mental exam. *Oakland Tribune, UPI, 3/28/67*

Ibid: declared mistrial. Kroman and other defendants all objected.

Said Garrison has most of it correct but not the whole story. Said he had been attacked 3/18/64 in a Tennessee motel and that on other occasions assailants had tried to take papers from him. Said he began his investigation in 12/63 when he heard "a drunken Cuban blabbing" in a Miami bar. *New York Times, 3/28/67*

Testified in court (without jury present): "Your honor, I have had countless incidents that have never been reported. They were trying to attack me try get material from me. This is not my imagination. I am playing a game I shouldn't have got involved in. I should have walked away from this in 12/63, but I didn't and made a mistake. Your honor, 19 people have died so far in the Kennedy investigation. Scores have been injured. It is miraculous that not one witness has ever been uncovered to either these killings or these injuries. I don't want to be the twentieth, but I will not stop."

Kroman said he became involved when he met a Cuban in Miami, FL, and was told that one Manuel Torres was the killer of President Kennedy. Kroman also said the assassination was planned and executed by "right-wingers" and that Lee Harvey Oswald had nothing to do with the killing. *Minneapolis Star, Paul Presbrey, 3/28/67*

Kroman not mentioned in story on acquittal on all counts of Kroman's four co-defendants, Kitzer Jr. & Sr., Hruban and Magnusson, on 6/23/67 at Bismarck. *New York Times, 6/24/67*

Kroman and 12 other remaining defendants acquitted by dismissal order by U.S. district judge in Minneapolis, requested by U.S. Attorney Patrick J. Foley. No mention of what has happened to Kroman. *New York Times, 7/26/67*
