

Yockey, Ross

New Orleans States-Item reporter. called a damn liar by William Gurvich when he questions Gurvich's claim to having an office in the Garrison office suite. *New Orleans States-Item*, 6/26/67

Subpoenaed for grand jury. NO *New Orleans States-Item*, previously been questioned. *New Orleans States-Item*, 6/28/67

Yockey has covered Garrison probe from near its start. He was believed questioned about information given him by Gurvich which may contradict what Gurvich now says. *New Orleans States-Item*, 6/ 29/67

Testified at Andrews trial regarding talks he had had with Garrison about Andrews, substance already made public. *New Orleans States-Item*, 8/9/67

Now with *WVUE-TV*, New Orleans. With 19 others, subpoenaed by Shaw defense for change of venue hearing. *New Orleans States-Item*, 2/29/68

Young, Aubrey

Former security officer for Gov. McKeithen. After *LIFE* magazine published an article saying Edward Grady Partin had turned down a bribe offer of \$1 million to recant his testimony which convicted Hoffa. Young said he had arranged a meeting between Partin and a public relations man who mentioned Hoffa's name, but that he (Young) left immediately thereafter. McKeithen issued a pious statement refusing to comment on the *LIFE* article and saying Young had left his employ after he learned of the meeting; also described Young as an alcoholic. *New Orleans States-Item*, 8/29/67

LIFE, in a third article charging criminal influence in Louisiana, says Young had ties with Carlos Marcello and was free spending guest of Mario Marino at Las Vegas. Marino is described as a friend of Marcello. *New Orleans States-Item*, 9/25/67

In new article (3rd) *LIFE* charges Marcello made calls to Young via private line into Gov.'s office, that Young was feted at Vegas by Marcello's aide, Mario Marino. McKeithen says Young has denied to him having talked or met wit Marcello, but says his trips to Vegas were one reason he fired Young. *New Orleans States-Item*, 9/26/67

Personality sketch, personal history; details of commitment to state hospital. *New Orleans States-Item*, Jack Owens, Baton Rouge, 9/28/67

Before Baton Rouge grand jury for second day. *Southern Bell Telephone* official says there may be firings if found any employee gave *LIFE* confidential info on Young's alleged calls to Marcello. *New Orleans States-Item*, 9/29/67

D'Alton Smith, New Orleans contractor, indicted by East Baton Rouge grand jury on charge of offering Young \$25,000 to arrange meeting with Partin. *New Orleans States-Item*, 9/30/67

Goes to Chicago with East Baton Rouge District Attorney Pitcher on fact-finding trip. *New Orleans States-Item*, 10/4/67

Young has turned state's evidence in the East Baton Rouge grand jury probe of criminal influence. *New Orleans States-Item*, 10/11/67

. *New Orleans States-Item* says Young was the one who hired Novel to de-bug McKeithen's office. *New Orleans States-Item*, 10/19/67

Testifies before New Orleans grand jury, says willing to testify in Jefferson parish too if they want him. Appears with Garrison after testimony, but does not talk. *New Orleans States-Item*, 11/2/67

D'alton Smith fights extradition from Texas at Austin hearing. His attorney, Jack Grady, says Smith's offer of \$25,00 to Young was just a friendly gesture to help someone in a financial bind. *New Orleans States-Item*, 11/29/67

D'Alton Smith makes surprise appearance with attorney Ossie B. Davis at Baton Rouge parish jail, surrenders and is released after posting \$7,500 court appearance bond for 1/31. *New Orleans States-Item*, 12/30/67

Jailed in Baton Rouge after being picked up in local bar, on authority of parish coroner Chester A. Williams. *New Orleans States-Item*, 1/3/68

Baton Rouge probe into phone link between Young and Marcello dropped when disclosed line led elsewhere. *New Orleans States-Item*, 1/25/68

Confusion in dual probe of Marcello links, by Bill Lynch. *New Orleans States-Item*, 1/30/68

Baton Rouge District attorney writes directly to Ramsey Clark and J. Edgar Hoover asking records of alleged phone calls between Young and Carlos Marcello. Says earlier requests sidetracked by Justice Department officials who refused to acknowledge they exist. *New Orleans States-Item*, 2/29/68

District Attorney says an investigation by his office shows no connection between Young and organized crime, as alleged by *LIFE* magazine. *New Orleans States-Item*, 4/19/68

Bill Lynch says learns Pitcher's probe shows no Marcello-Capitol link found in telephone probe. *LIFE* magazine invited to document its charges but does not do so. *New Orleans States-Item*, 7/5/68

Pitcher announces results of probe -- no undue links between Young and Marcello. *New Orleans States-Item*, 7/16/68

Young's arrest as a material witness in the D'Alton Smith bribery trial ordered by Baton Rouge court. *New Orleans States-Item*, 4/8/69

Smith trial day by day, ending in acquittal 4/17 after only one defense witness called and he not allowed to testify. *New Orleans States-Item*, 4/14-19/69

Youngblood

Warren Commission witness Nancy Perrin Rich alluded to a man named Youngblood who was a friend of her husband, Robert Perrin. Jones says he and Boxley located Youngblood in Dallas through Eddie Brawner, another Perrin friend mentioned by Nancy, and that Youngblood is neither Rufus of Secret Service fame nor a CIA pilot and Cuban soldier of fortune as some critics have speculated. *Midlothian Mirror*, 1/2/69

Zapruder, Abraham

Dallas businessman who took the famous amateur movie of the assassination. Testified at Shaw trial. *New Orleans States-Item*, 2/13/69

By 2/17/69, Zapruder film had been shown 11 times at the Shaw trial, 9 of them before the jury. *New York Times*, Waldron, 2/18/69

Penn Jones says Zapruder has received \$500,000 on a 10-year contract for \$1 million from *LIFE* for his film. *Midlothian Mirror* [filed mags], 2/27/69

Died Aug 29, 1970. Penn Jones says he sold film to *LIFE* for \$1,000,000, to be paid at \$100,000 a year for 10 years. Says Zapruder also was born in Russia, coming to U.S. in 1920, had refused interview with Penn Jones, who says he knows of no one who knew Zapruder was Russian-born. *Midlothian Mirror*, 9/3/70 [Filed Necrology]

Zarza, Joseph G., Jr.

26, among 17 persons arrested with Judge Haggerty in 12/17/69 raid on stag party. When Haggerty acquitted, Assistant District Attorney John Volz says he'll prosecute Zarza and Max Williams on obscenity charges, and Victor M. Soto on gambling and resisting arrest. *New Orleans States-Item*, 1/27/70

Zelden, Sam Monk

Attorney for Dean Andrews, Jr. Says Andrews doesn't know whether Shaw and Bertrand are the same person. *New York Times*, 3/4/67

Attorney for Dean Adams Andrews. Appeared before District Judge Frank Shea 4/18/67 when Andrews pleaded innocent to five counts of perjury. Said he would ask to have indictment quashed because it doesn't specify where perjury took place. Granted 10 days by Judge Shea to file special pleadings. Says Andrews had never seen Shaw. *New York Times*, 4/19/67

On big day when critics of Garrison are appearing before and jury, appears with Andrews and says he plans to file new motion to quash Andrews indictment in the light of *NBC's* recent claim that there is a Clay Bertrand in New Orleans. *New Orleans States Item*, 6/28/67

Dismissed as Andrews' attorney as trial opens, due to differences over strategy. Andrews attacks District Attorney and asked for him to be recused and ad hoc District Attorney named for the trial.

Judge Shea, after dismissing Zelden, calls him back and makes him take Andrews appeal for a delay to state Supreme court, which is denied. *New Orleans States-Item*, 8/9/67

With the District Attorney, Irving Dymond and 40 other lawyers, petitions state Supreme court for a pension for Judge Haggerty. *New Orleans States-Item*, 12/9/70

Zibilich, Robert J.

Attorney who accompanied Judge Malcolm V. O'Hara when he went before federal grand jury for less than five minutes. Jury investigating allegations of a conspiracy to spring Hoffa. *New Orleans States-Item* 9/27/67

Named by Judge Braniff as ad hoc prosecutor in the Tom Bethell case after District Attorney, on defense motion, ordered to recuse himself because he is complainant in the case. *New Orleans States-Item*, 4/8/69

Informs Bethell defense the state has no written statements or admissions by Bethell that will be used at the trial. *New Orleans States-Item*, 4/22/69

Dismisses Andrews' charge of perjury against the District Attorney, then leaves town a month. *New Orleans States-Item*, 8/4/69

Acts as attorney for Judge Edward A Haggerty, Jr. when the Shaw trial judge, with newsmen tipped in advance, is arrested at stag party. Denies charges he solicited for prostitution, conspired to commit obscenity, simple battery of police and resisting arrest. *New Orleans States-Item*, 12/18/69

[for conduct of Haggerty trial, see Haggerty and Garrison]

Named by Judge O'Hara as special prosecutor of attorney Robert G.Haik, accused to misusing \$50,000

belonging to District Attorney's mother. *New Orleans States-Item*, 3/9/70
