# 4th Man Quizzed in 'JFK Plot' All Deny Any Conspiracy

NEW ORLEANS — (UPI) — In the last four days, four men have been questioned in District Attorney Jim Garrison's investigation into the assassination of President Kennedy.

Afterward, each man has said he knows nothing either of an assassination conspiracy or of any of the others allegedly implicated.

Garrison, however, says he has enough evidence to prove Kennedy was assassinated as part of a plot organized in New Orleans several months before the shots were fired in Dallas Nov. 22, 1963.

## 4TH MAN QUIZZED

The fourth man questioned was Dante Marochini.

Later he told newsmen: "I don't know anything about this."

Substantially the same thing was said by the other men questioned — Dean A. Andrews, a chubby attorney who appeared Thursday; Clay Shaw, a prominent businessman charged with conspiracy to murder, and James Lewallen, a former roommate of the late David W. Ferrie, whom Garrison also has implicated.

Marochini was questioned for 90 minutes. He was smiling when he entered and calm when he left.

## HINT OSWALD LINK

Reporters learned he may have worked for the Standard Coffee Co., in New Orleans at the same time as Lee Harvey Oswald.

Oswald worked for the company in the summer of 1963.

Standard neither would deny or confirm Marochini's employment.

# Fourth Man Quizzed in 'Dallas Plot'

## New Orleans

A fourth man to be subpoenaed in District Attorney Jim Garrison's widening assassination probe, Dante Marachini, entered Garrison's office yesterday with a grin.

"I don't know what this darn thing is all about," he told newsmen.

Marachini, 42, works as a "planning and specifications man" at the Chrysler-Michoud missile manufacturing plant here.

After being questioned for an hour and a half, Marachini left Garrison's office pursued by a crowd of newsmen. He hurried down the steps and ran away.

Three other men have been called into Garrison's office this week. Two were not held after being questioned.

## BAIL

The third, retired executive Clay L. Shaw was booked on conspiring to commit "the crime of murder of John F. Kennedy." He was later released on \$10,000 bond.

Records show that Marachini and Lee Harvey Oswald, identified by the Warren Commission as the man who killed Kennedy, once were employed at the same time by the same coffee manufacturer here, though in plants a block apart.

Garrison has said he will prove that President Kennedy was assassinated Nov. 22, 1963, as the culmination of a conspiracy started in New Orleans.

## WARRANT

In an application for a warrant to search Shaw's home, the district attorney's office said it had evidence that Shaw, Lee Harvey Oswald and free-lance pilot David W. Ferrie met at Ferrie's

apartment here in September 1963 and agreed "to kill John F. Kennedy."

Ferrie was found dead in bed February 22.

Shaw, 54, former managing director of the New Orleans International Trade Mart, has emphatically denied any such participation.

The other two men subpoenaed in Garrison's investigation were Dean Andrews, assistant district attorney in suburban Jefferson Parish (county) and James Lewallen, employee of a Boeing missile plant here. Lewallen once roomed with Ferrie. Oswald on occasion asked Andrews for legal advice.
