NEW ORLEANS, MARCH 7 (AP)-THE DEFENSE ATTORNEY FOR CLAY SHAW, WHO IS BOOKED WITH CONSPIRING TO MURDER PRESIDENT JOHN F. KENNEDY, SAID TONIGHT HE WILL FILE A MOTION IN COURT TOMORROW TO QUASH THE CHARGES.

"WE WILL FILE MOTIONS FOR PARTICULARS -- THE NATURE OF THE CRIME,
THE NAMES OF THE CO-CONSPIRATORS, THE NAME OF THE UNNAMED INFORMANT,"
SAID GUY JOHNSON, SHAW'S LAWYER.

"AND WE'LL FILE A MOTION TO SUPPRESS THE SEARCH WARRANT AND A MOTION TO QUASH."

ASKED ABOUT REPORTS HE PLANNED TO TRY MOVING THE CASE INTO FEDERAL COURTS, JOHNSON REPLIED: "RIGHT NOW THE CASE IS NOT IN A STAGE TO MOVE ANYPLACE. I DON'T KNOW IF IT EVER WILL BE. I MEAN, THERE ISN'T A (FORMAL) CHARGE."

SHAW, A PROMINENT NEW ORLEANS BUSINESSMAN AND FORMER MANAGING DIRECTOR OF THE PRESTIGIOUS INTERNATIONAL TRADE MART, IS THE ONLY MAN ARRESTED SO FAR IN DIST. ATTY. JIM GARRISON'S CONTROVERSIAL INVESTIGATION OF PRESIDENT KENNEDY'S ASSASSINATION.

GARRISON HAS PLEDGED THERE WILL BE ARRESTS AND CONVICTIONS AS A RESULT OF HIS PROBE INTO WHAT HE SAYS WAS A CONSPIRACY IN NEW ORLEANS WHICH RESULTED IN THE ASSASSINATION IN DALLAS, NOV. 22, 1963.

IN AN APPLICATION FOR A WARRANT TO SEARCH SHAW'S FRENCH QUARTER HOME LAST WEEK, GARRISON ALLEGED THAT SHAW, LEE HARVEY OSWALD AND DAVID W. FERRIE MET AND DISCUSSED "HOW THEY WOULD KILL JOHN F. KENNEDY."

SHAW, WHO IS FREE UNDER \$10,000 BOND, DENIED KNOWING OSWALD, THE MAN IDENTIFIED BY THE WARREN COMMISSION AS THE PRESIDENT'S ASSASSIN; OR FERRIE, A FREE-LANCE PILOT WHO DIED FEB. 22 WHILE UNDER INVESTIGATION BY THE DISTRICT ATTORNEY'S OFFICE.
