## Trial in JFK Plot Expected

NEW ORLEANS-District Attorney Jim Garrison tried today to convince a three-judge panel that his star witness tells the same tale of a plot to murder President Kennedy, whether he is under "truth serum" and hypnosis or not.

lawyers was a New Orleans eccentric named David W. Ferrie, and Lee Harvey Oswald actually did not plan to take active parts in the plot Russo says they discussed.

The admission put the plot charges somewhat in the realm of three men in the front row of a baseball stadium being called criminal conspirators because they shout "murder the ump" at about the same time.

## **FACES 20 YEARS**

The difference, of course is that Russo says Oswald was one of the men, and that a man, the President, was killed.

But Oswald and Ferrie are dead, and Shaw, who so far has had no action alleged against him—only some big talk — is facing a possible 20-year jail term.

## AGREED TO DRUG

Russo, who waited three years to come forward with his tale of a conspiracy, gave his consent to the drugging.

Although Garrison, the showman extraordinary who has engineered the prosecution, was not present in the court, his aides led Chetta to all but testify in open court that Russo told the same tale while under the drug that he told while not under its effect.

Chetta also testified Russo spoke freely and easily while Dr. Esmond Fatter of New Orleans had him under hypnosis, with Russo's consent and at Garrison's bidding.
