BSMARCK, N. D., March 27 (UPI)—A mistrial was declared in a \$3-million insurance fraud prosecution today because of a defendant's story that he was attacked by gunmen because he had vital information about President Kennedy's assassina-

The mistrial ruling applied only to this defendant, David R. Kroman. There are four other defendants

Fedreal District Court Judge Edward Devitt said in ordering the mistrial: "There is reasonable cause to believe that Kroman may be insane or otherwise so mentally incompetent that he is unable to assist in his own defense."

Kroman's \$5,000 recogniz kroman's \$5,000 recognizance bond and ordered him committed for 45 days to the Federal penal hospital at Springfield, Mo., for mental examination.
