NEW ORLEANS, APRIL 12 (AP)-DEAN ANDREWS, A WARREN COMMISSION WITNESS WHO ONCE REPRESENTED LEE HARVEY OSWALD ON MINOR LEGAL MATTERS, WAS REINDICTED FOR PERJURY WEDNESDAY BY THE ORLEANS PARISH (COUNTY) GRAND JURY.

THE NEW INDICTMENT SPECIFIED FIVE COUNTS OF PERJURY AND CITED ABOUT 2,000 WORDS OF HIS MARCH 16 TESTIMONY BEFORE THE GRAND JURY.

MOST OF THE TESTIMONY DEALT WITH ANDREWS' ENCOUNTER WITH A CLAY BERTRAND IN 1963. HE TOLD THE WARREN COMMISSION THAT BERTRAND TELEPHONED HIM AFTER THE ASSASSINATION OF PRESIDENT JOHN F. KENNEDY ASKING THAT HE REPRESENT OSWALD.

DIST. ATTY. JIM GARRISON CONTENDS THAT CLAY BERTAND WAS AN ALIAS USED BY CLAY L. SHAW, 54, THE WEALTHY RETIRED NEW ORLEANS EXECUTIVE CHARGED WITH CONSPIRING TO MURDER PRESIDENT KENNEDY, SLAIN IN DALLAS, TEX., NOV. 22, 1963.

ANDREWS, SUSPENDED FROM HIS POST AS ASSISTANT DISTRICT ATTORNEY IN SUBURBAN JEFFERSON PARISH, A FEW HOURS BEFORE THE ORIGINAL INDICTMENT, IS A SQUAT, JIVE-TALKING LAWYER, WHO COMPLAINED THAT GARRISON "SEEMS TO THINK I HAVE THE KEY TO THIS WHOLE BUSINESS."

THE TESTIMONY CITED IN THE REINDICTMENT QUOTED HIM AS SAYING IN PART:

I GET THE IMPRESSION YOU ALL WANT ME TO IDENTIFY CLAY SHAW AS CLAY BERTRAND. I'LL BE HONEST WITH YOU, THAT IS THE IMPRESSION I GET--

Q. WELL?

A. AND I CAN'T. I CAN'T SAY HE IS AND I CAN'T SAY HE AIN'T.

IN HIS GRAND JURY TESTIMONY, ANDREWS SAID EVEN IF HE WERE

TO COME FACE-TO-FACE WITH CLAY BERTRAND THE ONLY WAY HE MIGHT

RECOGNIZE HIM WOULD BE BY "INSTINCT ONLY."

OF PROPERTY VALUED AT \$1,074 FROM AN ALBERT BELLEVUE. BOTH ALLEGED

NOVEL, WHO APPEARED BEFORE THE GRAND JURY IN THE PRESIDENTIAL PROBE, SOLD HIS BAR AND WENT TO COLUMBUS, OHIO. THERE HE BRANDED GARRISON'S PROBE A "FRAUD."
