NEW ORLEANS (AP)-CLÁY L.SHAW'S ATTORNEY ASKED CRIMINAL DISTRICT COURT HERE TODAY TO DISMISS THE ASSASSINATION CONSPIRACY CHARGE FILED BY DIST. ATTY. JIM GARRISON AGAINST THE 54-YEAR-OLD RETIRED BUSINESSMAN.

THE LAWYERS MOVED TO QUASH A GRAND JURY INDICTMENT WHICH ACCUSES SHAW OF CONSPIRING WITH LEE HARVEY OSWALD AND THE LATE DAVID W. FERRIE TO ASSASSINATE PRESIDENT JOHN F.KENNEDY.

THE DEFENSE ALSO REQUESTED THE COURT TO SUBPOENA ALL OF THE RECORDS OF A PRIVATE ORGANIZATION OF BUSINESSMEN WHO CONTRIBUTED MONEY TO FINANCE GARRISON'S INVESTIGATION.

THE BUSINESS GROUP, CALLED TRUTH AND CONSEQUENCES, STARTED CONTRIBUTING WHEN GARRISON SAID USE OF PUBLIC FUNDS, REFLECTED IN PUBLIC RECORDS, HAMPERED HIS INVESTIGATION.

THE DEFENSE ASKED A DISCLOSURE OF GRAND JURY TESTIMONY AND PROCEEDINGS SURROUNDING SHAW'S INDICTMENT. THE ATTORNEYS ALSO DEMANDED THE RETURN OF FIVE CARTONS OF MATERIAL SEIZED AT SHAW'S FRENCH QUARTER HOME.

GARRISON'S OFFICE WAS GIVEN 30 DAYS TO STUDY THE MOTIONS AND FILE REPLIES.

SHAW'S HOME WAS SEARCHED MARCH 1, THE DAY HE WAS ARRESTED, AND HIS PERSONAL EFFECTS WERE SEIZED. SHAW IS FREE ON \$10,000 BOND. HE HAS PLEADED INNOCENT TO THE CHARGE.

FERRIE, A FORMER AIRLINE PILOT, WHO TOLD NEWSMEN HE HAD NOTHING TO DO WITH KENNEDY'S DEATH IN DALLAS, TEX., NOV.22, IN 1963, WAS FOUND DEAD AT HIS UPTOWN APARTMENT LAST FEB.22, FIVE DAYS AFTER THE GARRISON PROBE WAS MADE PUBLIC. THE CORONER SAID FERRIE DIED OF NATURAL CAUSES.

OSWALD WAS NAMED BY THE WARREN COMMISSION AS THE LONE ASSASSIN OF KENNEDY.
