NEW ORLEANS (AP)-THE JUSTICE DEPARTMENT ASKED A STATE JUDGE TODAY TO DISMISS A SUBPOENA DIRECTING AN FBI AGENT TO TESTIFY BEFORE THE ORLEANS PARISH GRAND JURY IN CONNECTION WITH DIST. ATTY. JIM GARRISON'S KENNEDY ASSASSINATION PROBE.

U.S. ATTY. LOUIS C.LACOUR FILED A MOTION ASKING CRIMINAL DIST.

COURT JUDGE BEN BAGERT TO QUASH THE SUBPOENA GARRISON OBTAINED FOR

REGIS KENNEDY. KENNEDY WAS ONE OF FOUR PERSONS SUBPOENAED TO

TESTIFY BEFORE THE GRAND JURY TODAY.

BAGERT SCHEDULED A HEARING MAY 16 ON THE MOTION.

LACOUR'S MOTION STATED THAT KENNEDY WAS ORDERED BY ATTY. GEN.
RAMSEY CLARK NOT TO TESTIFY.

"TRADITIONALLY FBI AGENTS DO NOT TESTIFY BEFORE STATE GRAND
JURIES WITH RESPECT TO INFORMATION OR MATERIAL GAINED BY THEIR
PERFORMANCE OF THEIR OFFICIAL DUTIES OR BY REASON OF THEIR OFFICIAL
STATUS, "THE MOTION SAID. "THIS RULE WAS BASED UPON THE SOUND
POLICY THAT THE INTEGRITY AND EFFECTIVENESS OF THE FBI IS PROTECTED
BY RESTRICTING SUCH INFORMATION AND MATERIAL TO FEDERAL LAW
ENFORCEMENT."

KENNEDY AND FORMER FBI AGENT WARREN DEBRUEYS INVESTIGATED NEW ORLEANS ASPECTS OF THE ASSASSINATION OF PRESIDENT JOHN F.KENNEDY IN DALLAS ON NOV.22, 1963. DEBRUEYS ALSO WAS SUBPOENAED TODAY.

CUBAN SOURCES IN NEW ORLEANS SAID THEY REMEMBERED KENNEDY AND DEBRUEYS ATTENDING MEETINGS OF ANTI-CASTRO GROUPS ORGANIZED TO FIGHT THE ISLAND'S COMMUNIST REGIME IN 1961.

GARRISON, EMERGING FROM THE GRAND JURY ROOM, WAS ASKED FOR HIS REACTION TO THE GOVERNMENT'S MOTION TO QUASH THE SUBPOENA.

"OBVIOUSLY WHAT IS HAPPENING IS THAT THE FEDERAL AGENTS INVOLVED ARE TAKING THE FIFTH AMENDMENT," HE SAID.

THE FIFTH AMENDMENT TO THE FEDERAL CONSTITUTION PROVIDES THAT NO INDIVIDUAL MAY BE REQUIRED TO GIVE TESTIMONY THAT CAN BE USED AGAINST HIM.

\*THIS ISN°T GOING TO STOP OUR INVESTIGATION, \* THE DISTRICT ATTORNEY ADDED. \*THERE'S NO WAY IN THE WORLD THEY CAN STOP IT. ALL THEY CAN DO IS SLOW IT DOWN. \*\*

IN ANOTHER DEVELOPMENT, GARRISON'S OFFICE OBTAINED A SUBPOENA WHICH WILL BE DIRECTED TO THE HEAD OF THE CENTRAL INTELLIGENCE AGENCY, DEMANDING WHAT GARRISON CONTENDS IS A SUPPRESSED PHOTOGRAPH OF LEE HARVEY OSWALD, TAKEN BY CIA AGENTS IN FRONT OF THE CUBAN EMBASSY IN MEXICO CITY IN NOVEMBER 1963.

NEW ORLEANS (AP)-THE ORLEANS PARISH GRAND JURY TODAY RESUMES ITS PROBE OF A KENNEDY ASSASSINATION CONSPIRACYWHICH DIST. ATTY.

JIMGARRISON SAYS OCCURRED IN NEW ORLEANS.

FOUR WITNESSES WERE SUBPOENAED TO APPEAR BEFORE THE GRAND JURY, TWO WERE FBI AGENTS WHO INVESTIGATED NEW ORLEANS ANGLES OF THE ASSASSINATION OF PRESIDENT JOHN F. KENNEDY IN DALLAS, TEX., NOV. 22, 1963.

THE WARREN COMMISSION DECIDED LEE HARVEY OSWALD, A NEW ORLEANS-BORNEX-MARINE, WAS THE SOLE ASSASSIN.

AS FBI AGENTS, WARREN DEBRUEYS AND REGIS KENNEDY QUESTIONED NUMEEROUSPEOPLE IN NEW ORLEANS CONCERNING OSWALD.

AMONG THE MEN KENNEDY QUESTIONED WERE DAVID W. FERRIE, A FORMER AIRLINES PILOT WHO DIED FEB. 22 OFNATURAL CAUSES WHILE UNDER INVESTIGATION BY GARRISON. FERRIE AND OSWALD WERE NAMED AS CONSPRATORS IN THE ASSASSINATION PLO WHEN THE GRAND JURY HERE INDICTED CLAY L. SHAW, 54-YEAR-OLD RETIRED EXECUTIVE, MARCH 22 FOR CONSPIRACY TO MURDER THE PRESIDENT.

ALSO ARRESTED WITH FERRIE IN 1963 AND QUESTIONED BY FBI
AGENT KENNEDY WASLAYTON PATRICK MARTENS, WHO HASBEEN INDICTED
FOR PERJURY IN CONNECTION WITH GARRISON'S INVESTIGATION.

GARRISON'S OFFICE ALSO ISSUED A SUBPOENA FOR CARLOS QUIROGA
TO APPEAR BEFORE THE GRAND JURY. GARRISON SAID HE WAS A CLOSE
ASSOCIATE OF SERGIO ARCACHA SMITH, ONETIME NEW ORLEANS CUBAN
EXILE LEADER WHO HAS BEEN CHARGED BY GARRISON WITH CONSPIRING TO
BURGLARIZE AN AMMUNITION BUNKER AT HOUMA, LA., IN 1961. ARCACHA
IS SOUGHT BY GARRISON FOR QUESTIONING IN THE CASE.

ALSO SUBPOENAED WAS OSCAR DESSLATTE, (CAP D, CAP 2ND S) A TRUCKSALESMAN WHO TOLD NEWSMEN HE WAS APPROACHED BY A MAN NAMED OSWALD WHO TALKED ABOUT BUYING A TRUCK.

FOUR WITNESSES WERE SUBPOENAED TO APPEAR BEFORE THE GRAND

JURY, TWO WERE FBI AGENTS WHO INVESTIGATED NEW ORLEANS ANGLES OF THE

ASSASSINATION OF PRESIDENT JOHN F. KENNEDY IN DALLAS, TEX., NOV. 22,

1963.

THE WARREN COMMISSION DECIDED THAT LEE HARVEY OSWALD, A NEW CRLEANS-BORN EX-MARINE WHO ONCE DEFECTED TO THE SOVIET UNION, WAS THE SOLE ASSASSIN.

AS FBI AGENTS, WARREN DEBRUEYS AND REGIS KENNEDY QUESTIONED NUMEROUS PEOPLE IN NEW ORLEANS CONCERNING OSWALD AND ALSO INVESTIGATED OTHER REPORTS AND TOPS.

AMONG THE MEN MENNEDY QUESTIONED WERE DAVID W. FERRIE, A FORMER AIRLINES PILOT WHO DIED FEB. 22 OF NATURAL CAUSES WHILE UNDER INVESTIGATION BY GARRISON. FERRIE AND OSWALD WERE NAMED AS CO-CONSPIRATORS IN THE ASSASSINATION PLOT WHEN THE GRAND JURY HERE INDICTED CLAY L. SHAW, 54-YEAR-OLD RETIRED EXECUTIVE, ON MARCH 22 FOR CONSPIRACY TO MURDER THE PRESIDENT.

ALSO ARRESTED WITH FERRIE IN 1963 AND QUESTIONED BY FBI AGENT KENNEDY WAS LAYTON PATRICK MARTENS, WHO HAS BEEN INDICTED FOR PERJURY IN CONNECTION WITH GARRISON'S INVESTIGATION.

GARRISON'S OFFICE ALSO ISSUED A SUBPOENA FOR CARLOS QUIROGA TO APPEAR BEFORE THE GRAND JURY. HE WAS A CLOSE ASSOCIATE OF SERGIO ARCACHA SMITH, ONETIME NEW ORLEANS CUBAN EXILE LEADER WHO HAS BEEN CHARGED BY GARRISON WITH CONSPIRING TO BURGLARIZE AN AMMUNITION BUNKER AT HOUMA, LA. IN 1961. ARCACHA IS SOUGHT BY GARRISON FOR QUESTIONING IN THE CASE.

ALSO SUBPOENAED WAS OSCAR DESSLATTE, (CAP D, CAP 2ND S) A TRUCK SALESMAN WHO TOLD NEWSMEN HE WAS APPROACHED BY A MAN NAMED OSWALD WHO TALKED ABOUT BUYING A TRUCK.
