"ALL OF US ARE PROUD OF JIM GARRISON AND ARE STILL BEHIND HIM 100 PER CENT," ROBERTSON SAID FRIDAY. CRIMINAL DIST. JUDGE EDWARD A. HAGGERTY JR., THURSDAY ORDERED THE GROUP, KNOWN AS TRUTH AND CONSEQUENCES, INC., TO DISCLOSE ITS MEMBERS AND FINANCIAL CONTRIBUTIONS MADE TO GARRISON.

ROBERTSON SAID GARRISON HAD SPENT ALL BUT \$386 OF \$9,418 DONATED SINCE FEBRUARY.

HE ALSO SAID THE GROUP WAS CHANGING ITS NAME TO TRUTH OR CONSEQUENCES OF NEW ORLEANS, INC., SINCE THE ORIGINAL NAME HAD BEEN REGISTERED WITH THE SECRETARY OF STATE'S OFFICE IN BATON ROUGH AGARRISON FOE, ATTORNEY DEAN A. ANDREWS JR.

ANDREWS, WHO REPRESENTED LEE HARVEY OSWALD ON MINOR LEGAL MATTERS HERE IN THE SUMMER OF 1963, HAS BEEN INDICTED FOR PERJURY. HE WAS ACCUSED OF LYING TO THE PARISH (COUNTY) GRAND JURY WHICH HAS BEEN HEARING GARRISON PRESENT HIS ASSASSINATION CONSPIRACY INVESTIGATION.

DEFENSE ATTORNEYS FOR CLAY L. SHAW, 54, RETIRED BUSINESS EXECUTIVE, ACCUSED BY GARRISON OF CONSPIRING TO MURDER PRESIDENT JOHN F. KENNEDY, GO BEFORE JUDGE HAGGERTY ON MONDAY WITH MOTIONS SEEKING TO QUASH THE INDICTMENT. SHAW HAS BEEN FREE ON \$10,000 BOND SINCE HIS ARREST MARCH 1.
