DENIED CLAY L.SHAW'S LEGAL DEFENSE TEAM THE RIGHT TO INSPECT THE

RECORDS OF THE PRIVATE GROUP FINANCING DIST. ATTY. JIM GARRISON'S

KENNEDY ASSASSINATION PROBE.

GARRISON HAS CHARGED SHAW WITH CONSPIRING TO KILL PRESIDENT JOHN

F.KENNEDY. FOR THE PAST FEW MONTHS, GARRISON'S INVESTIGATIVE WORK

HAS BEEN SUBSIDIZED BY AN ORGANIZATION KNOWN AS "TRUTH AND

CONSEQUENCES OF NEW ORLEANS, INC." AS OF LAST WEEK, THE GROUP HAD

DONATED MORE THAN \$9,000 TO GARRISON'S PROBE.

HAGGERTY'S RULING CAME AT A PRE-TRIAL HEARING REQUESTED BY SHAW'S

ATTORNEYS IN AN ATTEMPT TO QUASH THE CONSPIRACY INDICTMENT AGAINST

SHAW, HAVE HIS SEIZED BELONGINGS RETURNED, AND HAVE THE DISTRICT

ATTORNEY PROVIDE A BILL OF PARTICULARS CONCERNING THE ALLEGED

CONSPIRACY.

F. IRVIN DYMOND, AN ATTORNEY FOR SHAW, ARGUED THAT WITHOUT THE

LIST OF MEMBERSHIP OF THE FINANCING GROUP, "WE WOULD BE FORCED TO

RELY ON THE TESTIMONY OF GRAND JURORS WHETHER THEY WERE MEMBERS OF

THE GROUP, WHETHER THEY HAVE AN INTEREST IN IT AND WHETHER THEY

HAVE RELATIVES IN TRUTH AND CONSEQUENCES COME CLOSE TO VIOLATING

THE STATUTES OF PUBLIC BRIBEY...GIVING MONEY FOR PURPOSES OF

INFLUENCING PUBLIC OFFICIALS," DYMOND ADDED.

JUDGE HAGGERTY TOLD THE PROSECUTION TO MAKE A LIST OF ALL MEMBERS OF TRUTH AND CONSEQUENCES AND GIVE IT TO THE COURT. HE SAID THE LIST WOULD BE SEALED, SO THAT IF THE DEFENSE ALLEGED AFTER THE TRIAL THERE WERE CONNECTIONS BETWEEN TRUTH AND CONSEQUENCES AND GRAND JURORS, THERE WOULD BE SOME WAY OF CHECKING. HE ALSO ORDERED GARRISON TO KEEP A RECORD OF MONEY RECEIVED FROM TRUTH AND CONSEQUENCES AND PRESENT IT TO THE COURT AFTER THE SHAW TRIAL.

THE JUDGE SAID DONORS TO TRUTH AND CONSEQUENCES MAY HAVE HAD GOOD REASON FOR THEIR ACTIONS.

"I SEE NO REASON TO IMPUGN THE MOTIVES OF CITIZENS WHO MAY HAVE GOING TO MAKE THAT LIST PUBLIC."

GARRISON, WHO DISAGREES WITH THE WARREN COMMISSION FINDINGS THAT
LEE HARVEY OSWALD ACTED ALONE IN THE SLAYING, MAINTAINS SHAW, DAVID
FERRIE OF NEW ORLEANS, JACK RUBY, AND OSWALD CONSPIRED IN THE KILLING.
RUBY, FERRIE AND OSWALD ARE DEAD.

THIRTY-THREE PERSONS HAVE BEEN SUBPOENAED FOR THE HEARING, INCLUDING SEVEN CRIMINAL DISTRICT JUDGES. ALSO SUBPOENAED WERE GARRISON,
THE 12 GRAND JURORS WHO INDICTED SHAW, AND ORGANIZERS OF TRUTH AND
CONSEQUENCES INC. OF NEW ORLEANS.

THE ORGANIZATION IS COMPOSED OF BUSINESSMEN WHO ARE FINANCING
GARRISON'S INVESTIGATION.
