NEW ORLEANS (AP)-JUDGE BERNARD J. BAGERT HELD JOHN (THE BAPTIST) CANCLER IN CONTEMPT OF COURT WEDNESDAY FOR REFUSING TO ANSWER A QUESTION PUT TO HIM BY THE GRAND JURY IN THE KENNEDY ASSASSINATION PROBE.

BAGERT, IN A HASTILY SUMMONED CRIMINAL DISTRICT COURT SESSION.
SENTENCED CANCLER TO A \$500 FINE AND SIX MONTHS IN JAIL. WITH THE
JAIL TERM TO EXTEND ONE YEAR IF THE FINE WERE NOT PAID.

THE QUESTION PUT TO CANCLER BY THE FOREMAN OF THE ORLEANS PARISH
GRAND JURY: "WAS THE STATEMENT YOU MADE ON NATIONAL TELEVISION DURING
THE MONTH OF JUNE TRUE?"

CANCLER, A NEGRO WHO SAYS BURGLARY IS HIS PROFESSION. THEN TOLD
THE JUDGE, "I REFUSE TO ANSWER ON THE GROUNDS THAT IT MIGHT INCRIMINATE

CANCLER WAS ONE OF THE PERSONS WHO APPEARED ON THE JUNE 19 PROGRAM BY THE NATIONAL BROADCASTING CO., WHICH WAS HIGHLY CRITICAL OF DISTATTY. JIM GARRISON'S ASSASSINATION PROBE.

AFTER THE BRIEF COURT SESSION THE GRAND JURY FILED BACK TO THE GRAND JURY ROOM AND CALLED WILLIAM GURVICH, THE FORMER CHIEF INVESTIGATOR FOR GARRISON, WHO NOW SAYS THE INVESTIGATION HAS TURNED UP NO SOLID EVIDENCE OF ANY NEW ORLEANS CONSPIRACY TO KILL PRESIDENT JOHN F. KENNEDY.

EARLIER WEDNESDAY, JUDGE EDWARD A. HAGGERTY JR., REFUSED TO FORBID GARRISON TO PARTICIPATE IN A SATURDAY NIGHT NBC TELEVISION OUTLINE OF HIS ASSASSINATION PROBE. AN INJUNCTION TO BLOCK THE PROGRAM, OR AT LEAST BLACK OUT THE NEW ORLEANS AREA, WAS SOUGHT BY LAWYERS FOR CLAY L. SHAW, 54, THE WEALTHY RETIRED BUSINESSMAN CHARGED WITH CONSPIRING TO MURDER PRESIDENT JOHN F. KENNEDY.
