CANCLER. A CONVICTED BURGLAR, DREW A STILL CONTEMPT OF COURT
PENALTY WEDNESDAY FOR REFUSING TO ANSWER A QUESTION POSED BY THE
ORLEANS PARISH GRAND JURY ABOUT HIS STATEMENTS ON TELEVISION LAST

ORLEANS PARISH GRAND JUKT ABOUT JUDGE IN NEW ORLEANS REFUSED TO ISSUE AN IN OTHER DEVELOPMENTS:

--A CRIMINAL DISTRICT COURT JUDGE IN NEW ORLEANS REFUSED TO ISSUE AN INJUNCTION WHICH WOULD HAVE FORBIDDEN GARRISON TO APPEAR ON NATIONAL
--IN WASHINGTON, WALTER J. SHERIDAN, AN INVESTIGATIVE REPORTER FOR ORLEANS TO FACE GARRISON'S CHARGE OF TRYING TO BRIEF A WITNESS.

CANCLER SAID ONE OF GARRISON'S INVESTIGATORS TRIED TO GET TO PLANT SOME EVIDENCE IN THE HOME OF CLAY L. \*\*-2.

IT WAS SHERIDAN WHO ARRANGED FOR AN ON-CAMERA INTERVIEW IN WHICH CANCLER SAID ONE OF GARRISON'S INVESTIGATORS TRIED TO GET HIM TO PLANT SHAW, 54, A WEALTHY RETIRED NEW ORLEANS BUSINESSMAN, IS CHARGED WITH CONSPIRING TO MURDER PRESIDENT JOHN F. KENNEDY, WHO WAS CANCLER'S STORY WAS ONE OF SEVERAL WHICH NBC USED IN AN HOUR-LONG CRITICAL EXAMINATION OF GARRISON'S CASE AGAINST SHAW.

CALLED BEFORE THE GRAND JURY, CANCLER WAS ASKED IF HIS STATEMENT CHIVPEEVIS BUNIMER IMENETE HE REFUSED TO ANSWER ON THE GROUND THAT HIS

ON TELEVISION WAS TRUE. HE REFUSED TO ANSWER ON THE GROUND THAT HIS REPLY MIGHT INCRIMINATE HIM.

THE GRAND JURY THEN LEFT ITS PRIVATE ROOM AND FILED INTO CRIMINAL DIST. JUDGE BERNARD BAGERT'S COURTROOM.

AFTER JUDGE BAGERT HASTILY CONVENED THE COURT. JURY FOREMAN A. V. LABICHE REPEATED THE QUESTION TO CANCLER, WHO AGAIN REFUSED TO ANSWER ON THE GROUND OF POSSIBLE SELF INCRIMINATION.

JUDGE BAGERT CONVICTED CANCLER OF CONTEMPT AND IMPOSED PUNISHMENT OF A \$500 FINE AND SIX MONTHS IN JAIL. IF THE FINE IS NOT PAID, A YEAR WILL BE ADDED TO THE JAIL SENTENCE. THE JUDGE SAID.

THE GRAND JURY ALSO RECALLED FORMER CARRISON CHIEF INVESTIGATOR WILLIAM GURVICH AND QUESTIONED HIM 2 1/2 HOURS. GURVICH, 42, A PRIVATE INVESTIGATOR, BROKE WITH GARRISON AND NOW SAYS THE PROBE IS ALL THEORY AND LITTLE EVIDENCE.

"GARRISON WAS IN THERE DURING THE EARLY PART, 73#) #E

ALL THEORY AND LITTLE EVIDENCE.

"GARRISON WAS IN THERE DURING THE EARLY PART, UNTIL HE CHICKENED-UNTIL HE LEFT," SAID GURVICH.

THE SATURDAY NIGHT TELEVISION SHOW IS A HALF HOUR GIVEN TO GARRISON
BY NBC FOR HIS REPLY TO THE JUNE 19 PROGRAM. THE FUTILE LEGAL EFFORT
TO BLOCK THE PROGRAM, OR AT LEAST BLACK IT OUT IN THE NEW ORLEANS AREA,
WAS FILED BY SHAW'S DEFENSE LAWYERS.

F. IRVING DYMOND ARGUED THAT THE PROGRAM WOULD VIOLATE COURT
GUIDELINES ON THE CONDUCT OF LAWYERS OR WITNESSES INVOLVED IN THE
CASE. HE ALSO SAID IT WOULD PREJUDICE THE CASE AGAINST SHAW.

CRIMINAL DIST. JUDGE EDWARD A. HAGGERTY JR., WHO WILL PRESIDE AT
THE SHAW TRIAL, SAID HE ALREADY HAD GIVEN CLEAR NOTICE THAT PERSONS
VIOLATING THE GUIDELINES DO SO AT THEIR OWN PERIL.

"I CANNOT IN ADVANCE ANTICIPATE OR SUSPECT THAT A VIOLATION WILL
OCCUR." HE SAID. "A REMEDY YET AVAILABLE TO THE COUNSEL FOR THE
DEFENSE, TO BE FILED AT THEIR DISCRETION, IS A MOTION FOR A
CHANGE OF VENUE."

THE GUIDELINES FORBADE ANY PERSON CONNECTED WITH THE CASE TO MAKE
ANY PUBLIC STATEMENTS, OUTSIDE THE COURT, AS TO GUILT, INNOCENCE
OR EVIDENCE.

ANY PUBLIC STATEMENTS, OUTSIDE ANY SAID HE WON'T DODGE ARREST BECAUSE THE CHARGE AGAINST HIM "INVOLVES A BASIC PRINCIPLE OF FREEDOM OF THE PRESS."

ANOTHER TV NEWSMEN, RICHARD TOWNLEDMF WDUUATV IN NEW ORLEANS, AN NBC AFFILIATE, SURRENDERED TUESDAY ON THE SAME CHARGE. HE WAS FREE UNDER \$7,500 BOND.
