AFTER HIS TV APPEARANCE, NBC COMMENTED: "DIST. ATTY. JIM

INFORMATION DEVELOPED BY NBC NEWS ABOUT THE METHODS HE USED . ."
THE DISTRICT ATTORNEY HAS CHARGED CLAY SHAW, A NEW ORLEANS
BUSINESSMAN, WITH CONSPIRING WITH LEE HARVEY OSWALD AND DAVID
FERRIE, BOTH NOW DEAD, TO KILL PRESIDENT KENNEDY.
THE WARREN COMMISSION NAMED OSWALD AS THE SOLE ASSASSIN AND
SAID IT FOUND NO EVIDENCE OF A CONSPIRACY.
GARRISON SAID ON HIS TAPED PROGRAM, "IN MY CONSIDERED

NBC REPORTED IT LOCATED THE TRUE CLAY BERTRAND (GARRISON CONTENDS BERTRAND WAS AN ALIAS FOR SHAW) AND GAVE THIS INFORMATION TO THE U.S. DEPARTMENT OF JUSTICE. GARRISON REPLIED THAT THE MAN TO WHOM NBC REFERRED DENIED HE IS BERTRAND.

"NBC NEWS STANDS BY THE STATEMENT MADE ON ITS PROGRAM,"
THE NETWORK SAID IN REBUTTAL.
