CHICAGO (AP)-A WITNESS AT A FEDERAL HEARING TESTIFIED TODAY
THAT HE WAS HIRED IN 1961 TO PLANT AN ELECTRONIC EAVESDROPPING DEVICE
IN A MIAMI HOTEL ROOM REGISTERED TO JAMES HOFFA, IMPRISONED TEAMSTER
UNION PRESIDENT.

THE WITNESS, HAROLD JENKINS OF MIAMI, WAS CALLED BY HOFFA'S LAWYERS
AT A HEARING ORDERED BY THE SUPREME COURT TO DETERMINE WHETHER
ADMITTED GOVERNMENT WIRETAPPING OBTAINED EVIDENCE THAT HELPED
CONVICT HOFFA AND SIX OTHERS OF FRAUD AND CONSPIRACY IN 1964.
HOFFA WAS SENTENCED TO FIVE YEARS IN PRISON AND FINED \$10,000.
HE IS SERVING AN EIGHT-YEAR FEDERAL SENTENCE FOR JURY TAMPERING IN
CHATTANOOGA, TENN. A CASE UNRELATED TO THIS HEARING.

JENKINS, WHO SAID HE HAS BEEN EMPLOYED AS A PRIVATE INVESTIGATOR,
TESTIFIED THAT HE WAS CONTACTED IN JANUARY 1961 BY JACK WIGGINS,
A MANUFACTURER OF BUGGING EQUIPMENT WHO SET UP A MEETING BETWEEN
JENKINS AND A RECENT CUSTOMER.

JENKINS SAID THE BUYER OF THE ELECTRONIC EQUIPMENT

JENKINS SAID HE WAS INSTRUCTED BY FETTERMAN TO PLANT THE DEVICE
IN ROOM 1102 OF EDEN ROCK HOTEL AND TO MONITOR IT FOR 10 DAYS FROM
FEB.1 TO 10. JENKINS SAID HE AGREED TO \$75 DAILY SALARY, BUT HE
WAS PAID ONLY \$45.
HE SAID HE RECORDED APPROXIMATELY ONE AND ONE-HALF HOURS OF
CONVERSATION EACH DAY AND TURNED THE TAPES OVER TO FETTERMAN EACH
EVENING.

UNDER CROSS-EXAMINATION BY SPECIAL PROSECUTOR DONALD PAGE MOORE, JENKINS REFUSED TO REVEAL WHOM HE HEARD ON THE TELEPHONE OR THE SUBJECT OF THE CONVERSATIONS.

MAURICE WALSH, CHIEF COUNSEL FOR HOFFA, OBJECTED TO MOORE'S ATTEMPTS TO SHOW THAT THE WITNESS HAD ILLEGALLY INTERCEPTED A TELEPHONE CALL AND JENKINS THEN INVOKED THE FIFTH AMENDMENT TO EACH OF MOORE'S QUERIES REGARDING THE EAVESDROPPING.

JENKINS SAID HE BECAME INVOLVED AS A WITNESS AFTER HE MENTIONED
THE BUGGING JOB TO ANOTHER INVESTIGATOR. HE WAS SUMMONED BY A MIAMI
BUSINESS ASSOCIATE OF HOFFA AND LATER FLEW TO WASHINGTON FOR
TALKS WITH HOFFA AND HIS LAWYERS.

HE SAID HE RECEIVED NO PAYMENT FROM THE TEAMSTER UNION.
MOORE ASKED: "DID YOU KNOW THAT A REWARD OF \$225,000 WAS OFFERED
FOR INFORMATION ON WIRETAPPING OF HOFFA.

"WHERE DID YOU GET THAT FIGURE?" JENKINS SAID.
MOORE REPLIED THAT HE HAD SEEN IT IN A NEWSPAPER. JENKINS REACHED
INTO HIS POCKET AND PRODUCED A NEWSPAPER ADVERTISEMENT: "THERE IT IS,
\$200,000," HE SAID.

CHICAGO (AP)-AN ORLEANS PARISH, LA., CRIMINAL JUDGE TESTIFIED

JUDGE MALCOLM O'HARA, A FORMER LOUISIANA STATE SENATOR AND
ASSISTANT ORLEANS PARISH DISTRICT ATTORNEY, TOOK THE STAND DURING A
U.S. DISTRICT COURT HEARING TO DETERMINE IFILLEGALLY OBTAINED WIRETAP
EVIDENCE HAD BEEN USED TO CONVICT HOFFA. THE HEARING WAS ORDERED BY

THE JUDGE'S TESTIMONY FOLLOWED TESTIMONY BY THE BUILDER HIMSELF,

STRATE WAS SENTENCED TO THREE YEARS IN PRISON AND FINED \$5,000 FOR
HIS PART IN THE ALLEGED CONSPIRACY TO DEFRAUD A TEAMSTERS UNION PENSION
FUND OF SOME \$20 MILLION. HE IS STILL FREE ON APPEAL BOND. HOFFA ALSO
IS APPEALING HIS CONVICTION AT THE 1964 CHICAGO TRIAL, FOR WHICH HE
WAS SENTENCED TO FIVE YEARS IN PRISON AND A \$10,000 FINE. HIS BASE
OF OPERATION IS A FEDERAL PRISON CELL IN LEWISBURG, PA., WHERE HE
IS SERVING A SENTENCE UPON CONVICTION OF JURY TAMPERING.

JUDGE O'HARA TESTIFIED THAT STRATE HAD PAID THE JUDGE'S FARE ON
SEVERAL TRIPS AROUND THE COUNTRY, INCLUDING A VISIT IN MAY TO TEAMSTERS
HEADQUARTERS, BUT HE SAID HE KNEW NO ONE THERE.

"MY ONLY PURPOSE WAS TO GO WITH STRATE," JUDGE O'HARA SAID. "HE
HATED TO GO ALONE AND I WENT WITH HIM AS A TRAVELING COMPANION. I JUST
SAT AROUND." HE SAID HE AND STRATE WERE FRIENDS OF LONG STANDING AND
THAT THEY HAD SPENT MUCH TIME TOGETHER SINCE O'HARA'S SEPARATION FROM
HIS WIFE.

ATTORNEYS ASKED O'HARA IF HE OWED \$30,000 TO STRATE AND IF HE WAS EVER PAID BY THE TEAMSTERS, BUT JUDGE RICHARD B. AUSTIN SUSTAINED OBJECTIONS TO BOTH QUESTIONS. O'HARA ADMITTED GOING TO BATON ROUGE, LA., WITH STRATE IN FEBRUARY, WHERE STRATE ASKED HIM TO SEE PARTIN AND PRESENT HIM WITH FEBRUARY, WHER THE AFFIDAVIT.

"I WAS JUST A MESSENGER." O'HARA TESTIFIED. BUT HE REFUSED TO SAY WHOSE MESSENGER HE WAS, DESPITE INTENSE CROSS-EXAMINATION BY GOVERNMENT ATTORNEY DONALD PAGE MOORE.

EARLIER, STRATE TESTIFIED THAT HE AND JUDGE O'HARA HAD TRAVELED TO WASHINGTON, LAS VEGAS, NEV., AND OTHER SPOTS AND "GENER-ALLY WHEN WE TRAVEL TOGETHER I PAY THE BILLS."

HE TESTIFIED TO A MEETING IN THE WASHINGTON OFFICE OF FRANK FITZSIMMONS; ACTING TEAMSTERS HEAD, INVOLVING HIMSELF, JUDGE O'HARA AND ANOTHER TEAMSTERS OFFICIAL.

STRATE REPLIED NEGATIVELY WHEN MOORE ASKED IF HE KNEW JUDGE O'HARA WAS IN DEBT DUE TO HIS UNSUCCESSFUL CAMPAIGN AGAINST JIM GARRISON FOR THE OFFICE OF ORLEANS PARISH DISTRICT ATTORNEY.

ON FRIDAY, STRATE HAD TESTIFIED THAT JUDGE O'HARA SET UP A MEETING BETWEEN STRATE AND WALTER SHERIDAN. SHERIDAN WAS AN AIDE TO FORMER ATTY. GEN. ROBERT F. KENNEDY, NOW A DEMOCRATIC SENATOR FROM NEW YORK. SHERIDAN IS NOW AN INVESTIGATIVE REPORTER FOR THE NATIONAL BROADCASTING CO.

SHERIDAN OFFERED TO GIVE STRATE EVIDENCE THAT THE GOVERNMENT USED ILLEGALLY OBTAINED WIRETAP EVIDENCE IN CHATANOGGA, IF STRATE WOULD HELP IN AN EFFORT TO DISCREDIT GARRISON'S PROBE OF THE ASSASSINATION OF PRESIDENT JOHN F. KENNEDY, STRATE TESTIFIED.

SHERIDAN WAS WILLING TO HELP STRATE AT THE CHICAGO HEARING IF STRATE WAS WILLING TO HELP SHERIDAN IN NEW ORLEANS, STRATE QUOTED SHERIDAN AS SAYING.
