GARRISON CHARGED BOTH MEN WITH ATTEMPTED BRIBERY OF A WITNESS
AIMED AT GETTING HIM TO CHANGE HIS STORY.

GARRISON'S CHARGE CAME AFTER A NATIONAL BROADCASTING CO.
TELEVISION SHOW WHICH EXAMINED IN CRITICAL DETAIL HIS CLAIM THAT
A CONSPIRACY TO ASSASSINATE PRESIDENT JOHN F. KENNEDY ORIGINATED IN
NEW ORLEANS.

SHERIDAN'S LAWYERS CLAIMED THAT, IF HE WENT BEFORE THE GRAND JURY FOR QUESTIONING, HE WOULD BE WITHOUT ADEQUATE LEGAL COUNSEL AND THAT GARRISON WOULD TRY TO INCRIMINATE HIM ON SOME OTHER POINT.

"WE FEEL STRONGLY THAT GARRISON DOES NOT INTEND TO STOP WITH ONE CHARGE." SAID DEFENSE ATTORNEY MILTON E. BRENER.

ASST. DIST. ATTORNEY JAMES L. ALCOCK SAID IT WAS "POSITIVELY" THE POSITION OF THE DISTRICT ATTORNEY THAT SHERIDAN WOULD NOT BE ASKED ABOUT ANYTHING CONNECTED WITH THE ATTEMPTED BRIBERY CHARGE.

ON THE ISSUE OF ENJOINING PROSECUTION OF SHERIDAN AND TOWNLEY, JUDGE RUBIN SAID THE QUESTION WAS WHETHER THEY HAD EXHAUSTED THEIR REMEDIES IN STATE COURTS.
