NOVEL, A 29-YEAR-OLD FORMER NEW ORLEANS BAR OPERATOR NOW LIVING
IN COLUMBUS, OHIO, IS DESCRIBED BY GARRISON AS A MATERIAL WITNESS
IN THE INVESTIGATION.
IN AN ATTEMPT TO EXTRADITE NOVEL, GARRISON CHARGED HIM WITH
CONSPIRING WITH SERGIO ARCACHA SMITH TO BURGLARY AN OIL SERVICE

GARRISON FILED A BILL OF INFORMATION IN WHICH HE ACCUSED NOVEL AND ARCACHA OF CONSPIRING TO BURGLARIZE THE SCHLUMBERGER WELL SERVICES CO. BUNKER AT AN ABANDONED MILITARY BASE HERE.

WHILE WAITING TO TESTIFY BEFORE THE GRAND JURY, GURVICH TOLD NEWSMEN NOVEL WAS "GROSSLY MISTREATED" BY GARRISON. "A DIRECT BILL OF INFORMATION WAS FILED AGAINST NOVEL AND ARCACHA WITHOUT GROUNDS," GURVICH SAID. "GARRISON WAS ADVISED THAT THE ALLEGED INSTANCES OCCURRED OUTSIDE HIS JURISDICTION."
