"WE BELIEVE THAT NO SUCH MEETING TOOK PLACE," EDWARD WEGMANN, AN ATTORNEY WHO SAID HE HAS REPRESENTED SHAW FOR 20 YEARS, TOLD A DALLAS NEWS CONFERENCE FRIDAY.

"WE ARE ASKING THE RESIDENTS OF THE DALLAS AREA FOR HELP IN ESTABLISHING THE WHEREABOUTS FOR RUBY DURING THIS TIME," HE SAID.

WEGMANN, HIS BROTHER, WILLIAM WEGMANN, AND F. IRVIN DYMOND,
A CRIMINAL ATTORNEY, SPENT THURSDAY AND FRIDAY IN DALLAS,
VISITING THE ASSASSINATION SITE AND THE SURROUNDING AREA AND
INTERVIEWING A NUMBER OF PERSONS.
THEY DECLINED TO SAY TO WHOM THEY HAD TALKED BUT LATER DURING
THE NEWS CONFERENCE SAID THAT PUBLIC OFFICIALS "HAD BEEN MOST
