NEW ORLEANS (AP)-ATTORNEYS FOR CLAY L.SHAW TODAY ATTACKED THE
SYSTEM BY WHICH GRAND JURIES ARE SELECTED IN A BID TO GET SHAW'S CASE
THROWN OUT OF COURT. SHAW HAS BEEN CHARGED BY DIST. ATTY. JIM
GARRISON WITH CONSPIRING TO ASSASSINATE PRESIDENT JOHN F.KENNEDY.

THE 54-YEAR-OLD SHAW, RETIRED MANAGING DIRECTOR OF THE
INTERNATIONAL TRADE MART HERE, LISTENED INTENTLY AS HIS LAWYERS
TRIED TO QUASH THE INDICTMENT AGAINST HIM.

CRIMINAL DISTRICT JUDGES WHO EMPANEL GRAND JURIES WERE QUESTIONED
CLOSELY AS TO WHY THE GRAND JURIES ARE MADE UP PRIMARILY OF WHITE MEN.

JUDGE BERNARD J.BAGERT, WHO EMPANELED THE GRAND JURY THAT INDICTED
SHAW LAST MARCH, TESTIFIED THAT HE HAS MADE CERTAIN THAT AT LEAST ONE
NEGRO WAS ON EACH GRAND JURY HE HAS PICKED.

THE JURY THAT INDICTED SHAW, HE SAID, INCLUDED A NEGRO NEWSPAPER
PUBLISHER AND A NEGRO EDUCATOR. "I WAS VERY PLEASED TO GET MEN OF
THIS CALIBER ON THE GRAND JURY." HE SAID.

IN ANSWERING QUESTIONS BY SHAW'S LAWYERS, JUDGE BAGERT SAID
WOMEN ARE EXEMPTED UNDER LOUISIANA LAW FROM JURY DUTY UNLESS THEY
VOLUNTEER. HE SAID HE HAS CONDUCTED A CAMPAIGN THROUGH NEWSPAPERS
TO INTEREST WOMEN IN STEPPING FORWARD AND VOLUNTEERING THEIR
SERVICES.

SHAW SAT AT THE DEFENSE TABLE AS HIS ATTORNEYS QUESTIONED THE SERVICES,

PRESIDING JUDGE EDWARD HAGGERTY JR. CAUTIONED THE DEFENSE THAT QUESTIONING OF WITNESSES WOULD BE VERY LIMITED BECAUSE THE ONLY ISSUE BEFORE THE COURT IS SHAW'S MOTION TO DISMISS THE INDICTMENT.

THE JUDGE SAID EARLIER HE WOULD RULE ON THE MOTION BU SEPT. 18.

SHOULD THE MOTION FAIL, IT WAS DEEMED LIKELY SHAW'S TRIAL WOULD GET UNDERWAY LATE THIS MONTH OR EARLY IN OCTOBER.

SHAW, 54, WAS ARRESTED MARCH 1.

HE IS THE ONLY MAN WHOM DIST. ATTY. JIM GARRISON HAS CHARGED IN THE CONTROVERSIAL PROBE OF AN ALLEGED PLOT IN NEW ORLEANS TO ASSASSINATE PRESIDENT KENNEDY IN THE FALL OF 1963.

LAWYERS FOR SHAW SUBPOENAED MORE THAN 3C WITNESSES, FOR THE HEARING, INCLUDING GARRISON'S PRIME WITNESS, PERRY RAYMOND RUSSO, WHO SELLS INSURANCE IN BATON ROUGE AND NEW ORLEANS, AND GARRISON HIMSELF.

IT WAS LARGELY ON THE BASIS OF RUSSO'S TESTIMONY THAT THREEJUDGE CRIMINAL COURT PANEL RULED THERE WAS SUFFICIENT CAUSE TO HOLD
SHAW FOR TRIAL. SHAW HAS BEEN FREE UNDER \$10,000 BOND.
THE BIG, WHITE-HAIRED BUSINESSMAN WHO ONCE SERVED AS MANAGING
