

## **Bradley Seeks** Hearing to Stop La. Extradition

LOS ANGELES (AP) gar Eugene Bradley, free on his own recognizance, sought an extradition hearing today to avoid a Louisiana trial in connection with the Kennedy assassination.

The final decision on whether the North Hollywood public relations man will be ex-tradited apparently will lie with Gov. Ronald Reagan of California,

As his lawyer pledged to fight extradition "every inch of the way," Bradley surrendered yesterday on a fugitive complaint based on a rant accusing him of conspiring to assassinate former President John F. Kennedy.

THE SURRENDER came six days after Dist. Atty. Jim. Garrison of New Orleans or-dered the warrant sent to Los

"Believe me, I don't have a thing to hide," said Bradley as he arrived with 20 friends in the office of Sheriff Peter J. Pitchess.

Bradley promptly in Municipal Court and released on his own recognizance. The hearing on the New Orleans fugitive com-plaint was continued to Jan.

son charged by Garrison in the 1963 assassination in Dallas, Tex. New Orleans busi-nessman Clay L. Shaw is awaiting trial under an indictment of conspiracy to commit murder.

Bradley's attorney, George J. Jensen, told newsmen he had asked Reagan's legal affairs secretary for a "full-fledged" extradition hearing on the assumption that Lou-isiana Gov. John McKeithen will file a request that Bradley be brought to New Orleans for prosecution.

LATER A GROUP called the Citizens' Committee of Inquiry urged Reagan by letter to extradite Bradley to permit a trial of the case. The group claims it represents group claims it 20,000 Americans.

Bradley has denied any prior knowledge that Kennedy would be killed, saying he was on a bus between Oklahoma and El Paso, Tex., at the time of the assassination.

"I know I'm not guilty of any crime. God knows I'm not guilty. That's the important thing," Bradley said after his arraignment.

Bradley lives in North Hol-lywood. He and his wife have a daughter and a son.
