NEW ORLEAMS (AP) -- A BARTENDER SUBPOENAED AS A MATERIAL WITNESS BY DIST. ATTY. JIM GARRISON SAID TODAY HE DISLIKED PRESIDENT JOHN F. KENNEDY BUT DENIED ANY KNOWLEDGE OF A CONSPIRACY TO KILL HIM. LORAN E. HALL, IN A TELEPHONE INTERVIEW WITH THE NEW ORLEANS STATES-ITEM FROM HIS BAR IN SUBURBAN KERNVILLE, CALIF., SAID HE FELT PRESIDENT KENNEDY "SHOULD HAVE BEEN REMOVED FROM OFFICE -- BY BALLOT, NOT BY BULLET." JOHN

M SAID HE WILL NOT RETURN OLUNTAILY TO NEME

HALL ALSO SAID HE WILL NOT RETURN VOLUNTARILY TO NEW ORLEAMS,
WHERE GARRISON WANTS TO QUESTION HIM IN CONNECTION WITH THE
CONTROVERSIAL PROBE OF WHAT GARRISON SAYS WAS A PLOT WHICH RESULTED
IN KENNEDY'S ASSASSINATION IN DALLAS, NOV. 22, 1963.
BUT IF A COURT ORDER IS ISSUED IN CALIFORNIA TO EXTRADITE MIM,
SAID HALL, "IN NATURALLY WILL GO TO NEW ORLEAMS. I HAVE ABSOLUTELY
NOTHING TO HIDE."
HALL, WHO GARRISON SAYS WAS ASSOCIATED WITH LEE HARVEY
CSWALD AND JACK RUBY IN DALLAS, SAID HE FIRST SAW RUBY "WHEN I,
LIKE THE REST OF AMERICA, SAW HIM SHOOT OSWALD ON TELEVISION."
OSWALD WAS NAMED BY THE WARREN COMMISSION AS THE LONE ASSASSIN
OF PRESIDENT KENNEDY, RUBY SHOT OSWALD IN THE DALLAS POLICE STATION
BASEMENT, WHILE TELEVISION CAMERAS WERE RECORDING THE REMOVAL OF
OSWALD FROM THE BUILDING TWO DAYS AFTER HIS ARREST.
HALL SAID HE WAS ARRESTED IN DALLAS IN SEPTEMBER 1963-TWO MONTHS
BEFORE THE ASSASSINATION—AND EARLIER IN MIAMI BECAUSE OF HIS PART
IN PROPOSED RAIDS ON COMMUNIST CUBA. HE SAID HE HAD PLANNED TO
TAKE MEDICAL SUPPLIES, ARMS AND AMMUNITION TO CUBAN REVOLUTIONARIES.
HE SAID HE WAS QUESTIONED BY CENTRAL INTELLIGENCE AGENCY AGENTS
AFTER HIS ARREST.

GARRISON, HALL SAID, IS INTERESTED IN HIM BECAUSE HE ONCE TOLD
FERSON WHOM MAS. ODIO SAID WAS INTRODUCED TO HER AS "LEON" OSWALD.
HOWEVER, HALL SAID TODAY HE NEVER ATTENDED ANY SUCH MEETING
BUT FALSELY TOLD THE FEDERAL BUREAU OF INVESTIGATION THAT HE WAS
THERE BECAUSE HE WAS "FRIGHTENED."
SINCE THE SUPPOMA WAS ISSUED, HALL SAID, HE HAS BEEN THE
TARGET OF HARASSING PHOME CALLS. HE SAID HE WAS "CONCERNED BECAUSE
OF THE UNNATURAL DEATHS OF SO MANY PEOPLE WHO HAVE BEEN INVOLVED IN
THE ASSASSINATION PROBE."
