Caller: Unless you would care to correspond with me, like -

Weisberg: Well, let me point some things out that could be of interest. First

of all, the point that you raised is a valid one, that there is a

broad homo -

Caller: (unintelligible) because you know the homo-erotic vote for Kennedy

was very strong, despite the fact that he only had, as he put it, a gnat's eyelash majority, yeah. There was - well, I - (long pause). Yes and no. I would like a casual correspondence, yeah, because I can, might point out some aspects of homosexuality that you may not

be aware of.

Weisberg: The thing - the one thing that would interest me very - well, first

of all, I'd like to make a general statement for the listeners

Weisberg: Many of the people involved, in New Orleans and what happened in the

assassination are or were homosexuals.

Caller: Sure, Ferrie, Bertrand, and - and actually I do think Oswald was -

how could you put it? -

Weisberg: A swinger?

Caller: Homo-erotic or something like that or -

Weisberg: This question was -

Caller: This, uh - a sunset world where a man is or a man isn't, you know,

and really he did play around with homosexuals. Ferrie certainly

was, and Bertrand is, or -

Weisberg: I think that when you talk about Oswald playing around, that ought to

be amplified because I know of no reason to believe that.

Caller: Well, he was at Ferrie's apartment which is -

Weisberg: That doesn't mean he was playing around with homosexuality. There

were other things going on there.

Caller: Yeah, yeah, yeah. Yeah, even though he wasn't surely a homo- - we -

Weisberg: Well, now this question -

Caller: - get into that evening world where is a man or isn't a man a

homosexual. But he, he -

Weisberg: Well, there is such a thing as being bi-sexual.

Caller: Yes.

Weisberg: And that question also came up.

Caller: That's - that's a big question.

Eason-Weisberg, 3

Eason: You guys remember this is a family program here.

Caller: Oh, are we on the air?

Eason: Let's don't get too explicit.

Eason: Yes, we are. Don't get too explicit, now.

Weisberg:) Yes, we're on the air. But we're all Night People, are we not?

Eason: Well, sure.

Caller: Sure, yeah. I, I - I'm no - uh, uh - I'm no, uh -

Eason: Well, now - but there may be a young FBI agent listening.

Caller: Ha ha ha.

Weisberg: But he probably has read books too. And besides that, he's working

for the right boss.

Weisberg: - we could get together and talk. Would you object to that?

Caller: No, heavens no.

Weisberg: Well, the problem is transportation. But I'd like it to suit your

Caller: No, I live here on top of Nob Hill about half a block away from
