* CE 2483, XXV, 681

"FBI report listing the contents of Lee Harvey Oswald's wallet at the time of arrest."

Page 4 only.

CE 2580, XXV, 851

"FBI analysis of allegations contained in book entitled 'The Red Roses of Dallas.'"

CE 2580, numbered items (Claim; Investigation). Page 1 of report missing. Starts with page 2, claim No. 4, pages 124 and 199 of book. No identification of book or author; probably on page 1 of report.

Ends with page 4 of the report and claim No. 15. No indication if this is the end of the report.

CE 2031, XXIV, 443

FBI report, four pages. Pages of report in ~~sequence~~ following sequence:

p. 20 - different copy of page 3 which appears on p. 21

p. 21 - p. 2, p. 3

p. 22 - p. 4, p. 1

p. 4, (different copy? - handwritten number is different) is numbered CE 2483, XXV, 681.

CE 2079 XXIV 514

FBI list of articles in Oswald's possession when arrested, p. 2 only. Appears again as CE 1986 (XXIV, 17), with p. 1 of list.

CE 2671 XXVI, 28

List of Oswald items, p. 21 only.

CE 2141-2174 XXIV, 748-847

Scripts of television programs, most of them incomplete.

CE 1984, XXIV, 16

Page 2 only.

CE 119, 120, XVI, xii)
CE 124, XVI, Xii)
CE 137, 138, XVI, xii)

Not included in exhibits. Notation in Contents, XVI: "these numbers were not used." CE 119, 120, 124, possibly items found with Oswald's belongings; CE 137 and 138, camera and flash attachment shown Marina which she said she had never seen before (I, 119).

CE 2581, XXV, 852

FBI report on Pauline Bates, who typed ms. for Oswald - page 2 only.

CE 2143, XXIV 754

Press interview of Jesse Curry, Nov. 23, 1963
"Q. What is the name of the rifle that was found in the sixth floor of the Depository Building?

Curry. That was -- "

CE 2546, XXV 771

FBI intv. of Charles Hall Steele, Jr., New Orleans, p. 1 only. Intv. deals with Oswald's activities in New Orleans.

CE 2549, XXV 774-776

"Secret Service report on historical information on past attacks and assassinations relating to American Presidents." Report apparently is at least 116 pages long (the last page given); the only pages reproduced are pages 22, 1-23, 1-25, 1-113, 1-115, 1-116

CE 1140, XXII 125

FBI report of intv with Warren N. Roberts, Jr., New Orleans Police, one of several officers who questioned Oswald after his arrest 9 Aug 63.

CE 3006, XXVI 529

FBI intv of Travis Kirk who says he knows Capt. Fritz and who has some uncomplimentary things to say about him; says it is inconceivable that Fritz did not know Ruby. Report stops in mid-sentence.
