None of the indices in the Report and supplements is organized according to subjects.

\* 1 - Contents

Listed by chapter headings.

In reading Report, to follow through on footnotes would need to check \*3 for volume and page number of Hearings or Exhibits. For complete testimony of any witness, would need to check \*6 or \*2, since testimony was given by certain witnesses on more than one occasion, and there is no indication of this at the beginning or end of each section of their testimony.

\* 2 - Appendix V

Alphabetical list of witnesses, with descriptions (Hoover, J. Edgar ... Director, FBI), and references to their testimony by volume and page number. Dates of their appearances not given, and no way to determine this without checking actual testimony: \*6, and then the specific volume or volumes. The date is given only at the beginning of the testimony of the first witness for that day; this date is not given for subsequent witnesses on that day and it is therefore necessary to leaf back, page by page, to the first witness, to find the date.

\* 3 - Appendix XVIII

References to footnotes, by chapter, giving volume and page number of Hearings or Exhibits where they may be found. Has helpful notation at top of page to footnotes by page sequence in Report.

\* 4 - Index

Alphabetical listing by names only (people, places: Love Field, Parkland Hospital, etc.).

Hearings, vols. I through XV

\* 5 - Contents, each volume

- a) Testimony: in sequence by page number. No alphabetical listing of witnesses.
- b) Exhibits introduced: includes only exhibits dealt with in testimony above (5a). While arranged alphabetically, cannot be used as alphabetical index of witnesses in 5a since it does not always include all of them. To find actual exhibits would still need to refer to \*11.

\* 6 - Index, vol. XV

Alphabetical listing by name of witness, giving volume and page number of testimony, and also where referred to by others.

\* 7 - Index, vol. XV  
Commission Exhibits

Master list, numerical, only through Exhibit No. 1053, with volume and page where discussed in Report of testimony.

\* 8 - Index, vol. XV  
Deposition Exhibits

Master list, alphabetical, for vols. XIX through XXI (see \*11); volume and page where discussed.

Exhibits, vols. XVI through XXVI

Any given exhibit can be located only if its specific number is known. To obtain the number, would need to check \*1, looking for a chapter heading which appears to deal with the exhibit concerned. If checking through this chapter proves unproductive, continue with another chapter or chapters until the exhibit actually is mentioned and actually has a footnote after it. When a footnote is found, check \*3, where the volume and page number for that footnote will be listed. (However, exhibits are not always grouped together; example: different views of the rear of Gen. Walker's house are in vol. XVI, listed as Commission Exhibit, and in vol. XXI, listed as Walker Exhibit.) An alternate method would be to check, item by item, Contents to vols. XVI through XXVI, but this would not necessarily be productive in each case (see example, \*12).

Generally no description given with individual exhibit to indicate what it is; would need to refer back to Contents of individual volume to find out.

\* 9 - Contents, each volume

Listing by exhibit number, with brief description of item.

\*10 - Contents, each volume  
vols. XVI through XVIII  
exhibits 1 through 1053

Listed in sequence by exhibit number, with brief description of item.

\*11 - Contents, each volume  
vols. XIX through XXI  
Allen through Yarborough

These are exhibits not listed in \*10 or \*12. Listed alphabetically by name, generally of the witness (sometimes of the photographer?), with subheadings of letters and numbers, not in sequence except under the name of each witness (example: Allen, J.U.: 1, 2, 3; Arnett, Charles O.: 5032, 5033, 5034; Barnes, W.E.: A, B, C.).

\*12 - Contents, each volume  
vols. XXII through XXVI  
exhibits 1054 through 3154

Listed in sequence by exhibit number, with brief description of item. Mainly FBI reports of investigations and interviews. The interviews are listed under the name of the person interviewed, with no alphabetical arrangement. (Example: investigation of Mrs. Sylvia Odio listed under the name of Mrs. C.L. Connell because she was interviewed to check Mrs. Odio's testimony; no indication of this in the listing.)

Exhibits numbered higher than 3154 in \*11.

No master numerical list beyond Exhibit 1053 (\*7); beyond this point no way to determine where exhibits are discussed in Report or testimony.

Decker Exhibit 5323, single entry, covers 89 pages of reports by members of  
Sheriff's Department, affidavits of witnesses, none of whom  
listed by name.
