THE SENATOR'S SON, JOSEPH, 14, REMAINS ON CRUTCHES. HE BROKE HIS LEG WHILE SKIING DEC. 23. HE WAS RELEASED FROM THE HOSPITAL TUESDAY.

SEVERAL OTHER PERSONS ARE AT SUN VALLEY WITH THE KENNEDYS.

THEY ARE KENNEDY'S SISTER, MRS. PAT LAWFORD, AND HER CHILDREN,
