Monday June 3

between 3-4p going from home in org city to oxnard to fetch pony had sold. going to stop off at hyd ranch market on errand.

stopped at light at 7th and grand. two young men asked for ride. one taller. one short. light chaged, told them to get in.

at stop just before vermont taler man jumped out and spoke to man in 30s and a girl. brief conversation. a second oldr man standing nearby.

slinder one stayed behind, sirhan rode on , talked of horses, like ornmaet, said execize boy, needed job on ranh said if had goodhorse he could get job at rrack.

palomino. woman wants to buy, ~~max~~ for \$300. wants to buy, asks to stop, wants to se friend in kitchen.

waited 10 mins, sirhan apoligized for being late.

if you ll meet me on sunset blvd at 11p ill have cash to pay you for this horse. mtg place:

bowling alley which used be warners bros studio.

mentioned club. are you jewish ? no, welch. I have no use for the heebs.

you mexican ? No born jordan. ~~is~~me here when 13, or been here 13 years, unsure which. most talk about hoses and how much he neded one.

just left club after 11p. 58-59 chevy, off white color, two men and girl in front seat. one man and girl same he

had sen during afternoon between 4-5p.

sirhan comes out of back seat, shows him 100 bill, cant get rest but wil have hn morning at 8a. repeated ver anxious to get horse. agreed go het horse, took room in cheap hotel.

next morning sirhan didnt come, but man in 30s, very well dressed, said joe cant make it, but he realy wants the horse can you have horse at 11p tonight at spot wher let him out yesterdays. said had out of town speaking engagement (oxnard) that night and couldnt make it.

offered 100 down. gave man his card with unlisted phone humber. offered deliver next morning. man in, car with him was the other boy who had been with sirhan.

wed  
next morning looked up old friend near usc.  
*Luis Hunt* *Coliseum in Hill at University* *36th place*  
bert morris. restaurant, lunch. dog lewis fight trainer walks in. girl cashier. news come on tx. first heard of rfk shooting. suspect still unidentified. picture came on, recognized. saw pix in hyd star, also recogd.

friends urged him to tell pox. resisted, argued man is in ~~custody~~ custody, pox unde<sup>Francis pointed out</sup>deed.

pox took in truck, blvs took prints. pox taped story. "The way I've told you." blvs could identify girl, the other boy. asks no publicity. "you hear all this stuff about the king case, and the oswald case."

4 hours  
held him until 6:30 getting sty. gave pox address and unlisted number.

2nd 3 days later. name wrong post.  
thursday first threatening call. kennedy had died during night, early morning. afternoon phone rings, wife and daught both answer, no reply. third time he answers, "you you so ,and so. Keep your ..... mouth shut. about this horse deal if you know whats good for you..

never heard voice before, or icant remember it, nomral american voice, no accent.

told wife call from ~~PKKMX~~ wrong number. went out back with horses and thought about it .

oxnard 3 days, on Monday june 10 get call from pox ask him to come ind to det bureau. takes jonathan perkins 79-year old minister friend.

picked out sirhans picture from about 30 others. zll looked like same nationality, but sirhan was only one he recognized.

asked if anything he hadnt told. reported threatening phone call. perkins asked if had picked out sirhan/ pox refused to say.

goes to pn and returns , due back in oxnard wed 26th - for speaz ng engagement.

drives to oakland at 7a thursday, phones hardister, on wed had had phone call from pø lt sandelin or sandlin. asked come down.

said couldnt, going to oxnard and oakland. sandelin  
 agreed dsmet him saturday am at palto hyatt house.  
 claimed knew him during his school. same age, 55.  
 saind in charge of investigation. told him could  
 get in touhh through davis or brother in san bruno.

in oa, while waiting for hardister, reads story in  
 paper about wirtesses disappearing in ray case in tean.

decided tell hardister, who ~~XXXXXX~~ sug's he go to  
 remote ranch. sug's be carefull about ~~not~~ meeting sandlin.  
 decide confer with davis. would be walking into somethng.

with davis, phoned hyatt housewhere unknew sandlin.

davis inquired in LA, where confirmed was lt sandlin  
 on pox force, and who supposed be in norcal this weekend.

howeder sandlin never apparently tried contact him.

chief reddin confired personnaly had such man.

told plans changed for him to be here, but no  
 xplaaation why hadnt tried to contact Minister.

they kinda brushed it off, safety problem, told not  
 to worry. asked his phone number. theyve got it.
