Coast Ruling Clears the Way for Ballistics Tests Asked by '2d Gun Theory' Backers NYTimes-

LOS ANGELES, Aug. 14-A state judge today ordered a reexamination of the ballistics evidence used to convict Sirhan B. Sirham of the assassination of Senator Robert F. Kennedy. Superior Court Judge Robert A. Wenke granted in principle a petition by several parties

who seek a refiring of the gun used to kill the Senator, as well as other ballistics material.

Thomas Krantz, the attorney appointed this morning to represent the district attorney's office in the case, stressed, however, that the judge's order does not officially reopen the Kennedy case.

"This is not a reopening," Mr. Krantz said. "The judge ruled on a motion to reexamine evidence that may have bearing on CBS, Schrade and other parties."

The petition asking to re-examine ballistics evidence was filed Aug. 4 by Paul Schrade, a former United Automobile Workers official who was shot in the forehead when Mr. Kennedy was fatally wounded July nedy was fatally wounded July 5, 1968; Allard K. Lowenstein, the former New York Representative who is now a consultant to Governor Jerry Brown, and

Judge Wenke delayed until Sept. 11 a decision on what "judicial guidelines and procedures" a re-examination would follow. Mr. Krantz said he was concerned that retesting of ballistics evidence be conducted in a "professional manner" by a court-appointed and independent examiners.

On Tuesday, the Los Angeles County Board of Supervisors voted to join the three parties in forcing public disclosure of the police investigative report. The Academy of Forensic Scientists is also seeking a reopening of the case.

Some advocates have suggested Some advocates have suggested that, because of discrepancies in ballistics tests, there is evidence that a second gun, in addition to the gun fired by Sirhan B. Sirhan, the convicted Kennedy assassin, was fired inside the Ambassador Hotel's pantry.

Aide to Senator Kennedy To Réview Aata on Slaving LOS ANGELES, Aug. 13

(UPI) Tom Kranz, an aide to Senator Robert F. Kennedy when Mr. Kennedy was assassinated, was named today to direct a review of the assassina-tion evidence by the District Attorney's office.

Mr. Kranz, a lawyer, will take office later this week as special counsel to the District Attorney, charged with taking

a "fresh look" at the case, the District Attorney's office said. Acting District Attorney John Howard said that Mr. Kranz would determine the best way to re-examine the pistol and bullets that were key evidence in the conviction of Sirhan B. Sirhan and have become sur-rounded by controversy.

The county Board of Super-

visors authorized Mr. Howard to hire Mr. Kranz for 60 days.

Mr. Kranz, 36 years old, was a political organizer for Mr. Kenin 1968, when the New York Senator was shot in a hotel kitchen here.

The controversy centers on allegations that evidence shows that some of the bullets fired in the hotel kitchen did not come from Mr. Sirhan's re-
