## Search for 'Galt' Turns To California

U.S. lawmen today scoured a corner of Southeast Californan nia - near Arizona and Mexico - in the hunt for the suspected assassin of Dr. Martin Luther King, identified yesterday as James Earl Ray. a habitual criminal and escaped convict.

Mexican officials also were reported looking for Ray alias Eric Starvo Galt - after an FBI alert was issued in the the Southwest area.

> Reward offers for Ray have risen to \$100,000.

Ray, 40, who fled the Missouri State Prison 51 weeks ago by hiding in a bread truck, was identified through

fingerprints after a 15-day check of the prints of more than 53,000 wanted criminals in FBI files.

The prints, FBI Director J. Edgar Hoover said in Washington, prove "that Galt and Ray are identical."

Hoover's announcement came as sources close to the investigation theorized the name Eric Starvo Galt may have been a code name for the murder of King at Mem-phis, April 4 The name appears in too many places at about the same time under varying descriptions of its user to be one man, these sources said.

## ALIASES

The FBI said Ray had assumed such aliases as Galt, Harvey Lowmeyer, John Willard, James McBride, James Walton, W. C. Herron and James O'Conner.

in Alton, Ill., had a criminal record dating to 1949 and was serving a 20-year, habitual criminal sentence at Jefferson City, Mo., for armed robbery and automobile theft when he escaped April 23,

Ray was working in the food service section of the prison and fled by hiding in a bread truck. A year earlier, he had tried to escape by hiding in the prison's ventilation system, but was discovered.
