The Justice Department staff overwhelmingly recommended a year mingly recommended a year ago that the government seek an indictment of Carmichael, but the attorney general vetoed the advice on grounds that it would only make him a mar-

The magazine said a Memphis man overheard a Memphis businessman "giving an unknown trigger man urgent, orders to kill King on the balcony of his motel, and even specifying the price for the job (\$5,000) and the pickup point for his fee (New Or-
