MEMPHIS, TENN. (AP)--POLICE SAID GERALD WILLIAM RAY, 32, IDENTIFIED AS THE BROTHER OF THE MAN CHARGED WITH KILLING DR. MARTIN LUTHER KING JR., HERE IN APRIL, WAS HELD BRIEFLY HERE TUESDAY ON A CHARGE OF PUBLIC DRUNKENNESS.

POLICE SAID RAY, WHO GAVE HIS ADDRESS AS ST. LOUIS, TOLD THEM HE WAS IN MEMPHIS "TO HELP MY BROTHER," JAMES EARL RAY.

JAMES EARL RAY IS APPEALING AN ORDER OF A LONDON COURT THAT HE SHOULD BE EXTRADITED BACK TO THE UNITED STATES SO HE CAN STAND TRIAL IN MEMPHIS FOR MURDER IN THE ASSASSINATION OF KING HERE APRIL 4.

POLICE SAID GERALD WILLIAM RAY WAS ARRESTED IN A TAVERN NEAR THE ROOMING HOUSE FROM WHICH OFFICERS SAY THE SHOT WAS FIRED THAT KILLED KING.

THE DRUNKENNESS CHARGE WAS DISMISSED AGAINST RAY BY CITY COURT JUDGE BERNIE WEINMAN AND HE WAS RELEASED

THE ST. LOUIS MAN SAID HE WAS IN ILLINOIS WHEN KING WAS SLAIN.
