Brief Ray Hearing In London

A Routine Appearance

LONDON - (AP) James Earl Ray made another brief appearance in the Bow Street magistrate's court today and was sent back to Wandsworth prison for another eight days.

Another court appearance for him was set for July 24.

Ray's British lawyers have indicated they will file their appeal tomorrow against Chief Magistrate Frank Milton's order of July 2 that Ray should be extradited to the United States.

He is wanted for trial in Memphis on charges of murdering Dr. Martin Luther King Jr.


A hearing on the appeal is tentatively scheduled for July 29.

James, in his letter from London's Heathfield Road Prison, asked that \$600 be sent to Birmingham attorney Arthur Hames, and said he would "straighten it up . . . when I get back."

He said the letter was the first communication from his brother since he escaped April 23, 1967, from the Missouri State Prison.

John said he last saw his older brother on April 22, the day before he broke out by hiding in the bread box of an outbound bakery truck.
