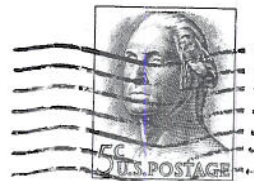

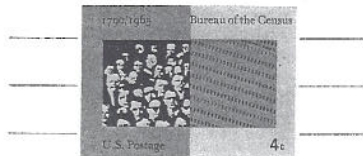

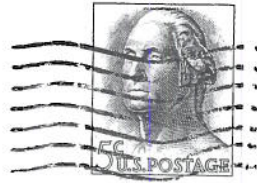

1. On August 12, 1963 a letter was written to Governor John Connally of Texas: A plot is under way to assassinate you. As a former Secretary of the Navy you are aware of the Shinarump Thresher disaster and how the Bondix Corporation used Rembrandt POSSIBLY/NEPTUN curves of equipment designed and built by Bondix for Submarines of the Thresher Class....An organization known as QUEERING FOR COPS OF THE THRESHERS, (PROOF) is being formed....SIB, I BEG OF YOU, if you do visit Dallas and RIDE IN AN OPEN CAR, please dont allow any of your loved ones to ride in an OPEN CAR WITH YOU.....

THE ORGANIZATION.....JFOOT
 THE WEAPON.....A HIGH POWERED RIFLE
 THE METHOD.....A SHIFER'S BULLET AS YOU RIDE IN AN OPEN CAR
 THE LOCATION.....A PARK IN DALLAS, TEXAS

2. Naval Officials and Postal Inspectors knew of this letter the latter part of August of 1963. This was THREE MONTHS PRIOR TO THE DALLAS TRAGEDY.

 B. Why did Naval Officials, both prior to and after the Dallas Tragedy, refuse to act?
