EL PASO, TEX., NOV. 14 (AP)-A PSYCHIATRIST TESTIFIED TODAY THAT A SAN MARCOS, TEX., MAN WAS INSANE AT THE TIME HE ALLEGEDLY SENT A LETTER THREATENING THE LIFE OF PRESIDENT JOHNSON.

THE RESTIMONY CAME AT THE FIRST DAY OF THE TRIAL OF SCHUYLER C. PROCK, 45, IN U.S. DISTRICT COURT.

JAMIE BOYD, ASSISTANT U.S. ATTORNEY, SPENT 35 MINUTES READING THE SIX-PAGE TYPEWRITTEN LETTER AND A THREE-PAGE RECITATION OF SABOTAGE CLAIMED BY BROCK AND HIS ASSOCIATES INCLUDING THE DEATH OF LATE PRESIDENT JOHN F. KENNEDY.

THE LETTER WAS SENT FROM SAN MARCOS LAST FEB. 12 TO THE PRESIDENT AT THE WHITE HOUSE. IT WAS SIGNED BY "SKY BROCK JR., COMMANDER, U.S. GUERRILLA FORCES, WEST."

THE LETTER ATTACKED THE GREAT SOCIETY, LABOR UNIONS, THE UNITED NATIONS, YANKEE IMPERIALISM AND CRUELTY INFLICTED ON THE SOUTH.

"WE SHALL SHOOT THE PRESIDENT OUT OF THE WHITE HOUSE THREE OR FOUR TIMES A YEAR WITH A CONTINUING AND WEARING MONOTONY," THE LETTER SAID, "AND BOMB THE U.N. OUT OF THE U.S."

DR. JOSEPH F. ALDERETTE, CALLED AS A GOVERNMENT WITNESS, STARTLED THE PROSECUTION BYSAYING THAT EXAMINATION OF BROCK AT THE GOVERNMENT HOSPITAL AT SPRINGFIELD, MO. INDICATED HE CLEARLY DID NOT KNOW RIGHT FROM WRONG. BOYD TRIED TO SHAKE ALDERETEE'S TESTIMONY BUT THE PSYCHIATRIST SAID HIS OPINION WAS UNANIMOUSLY SHARED BY THE PSYCHIATRIC STAFF OF WHICH HE IS HEAD.

BOYD THEN RESTED THE GOVERNMENT'S CASE.

BROCK'S COURT APPOINTED ATTORNEY, TOM LONG OF AUSTIN, WAS EXPECTED TO SEEK A DIRECTED VERDICT TOMORROW.
