Dear Coral and Jim:

Thank you for letting me know about Dr. Fontes. I have sent you a card with my sympathy - and one to Mrs. Fontes.

Enclosed are a few things. One is a transcript of various news items on radio the morning of the 11th of May. There is also a clipping from our paper on the same incident. Strange to me how the red-orange-yellow colors that were seen by observers suddenly changed to "whitish-orange" and blue-white when described by the Air Force.

Also enclosed is a copy of two columns that appeared in a Philadelphia newspaper - apparently a Negro publication from some of the copy on the reverse of the originals. The date is not known but both of these were sent to the UFO Research Organization within the past couple of months and before 7 May.

The other enclosure is a copy of some of what I have been working on. Day and night. It is compiled from a first quick trip through the last ten volumes of the Warren Commission exhibits. I have just completed a preliminary listing of the Commission Documents and their Exhibit numbers. So many times something is just cut off in mid-word and when you do come across the rest of it, you have forgotten where the first was. Steffen was moaning about not being able to complete something he was running down and I thought I would find it for him and got all involved in a job that turned out to be bigger than I anticipated.

This seems to be something that will be more complete than what anyone else has done so far as I have been able to find out. There are still a lot of gaps to be filled in and I am now working on that. But this is just to give you an idea of what I am doing.

I have been encouraged to complete it for publication. But you had told me your friends are working on an index and cross-reference. If it is to include anything like this and if they intend to publish it, I will just keep what I am doing for my own satisfaction, or even share it with them if they think it will be of any help. If this is not in their planned work, however, I will make some decision on publication when I complete it.

Will you please let me know? I want to be sure I do not duplicate something that has been done. Nor am I interested in competing. Just trying to do something to make a study of the 26 volumes a little easier.

Your new book - I just can't praise it enough. It is the very best UFO book I have ever read. Had to keep reminding myself it was written by people I know. How you will ever surpass it, I can't imagine. I know no one else will be able to do so. My congratulations.

I came across a similarity on pp 179-180. The report from Newfield, N. J., on the 24th October 1967. Donald Chiszar and Pat Crosier. Last Fall sometime you were sent a report from the Cape Kennedy or Cocoa area. This was sent by the chairman of the NICAP Sub-Committee over there and it was for real, in case you suspected it. They sent it to you since they said they believed it would receive the proper attention from APRO and, since it involved creatures, would be disregarded by NICAP. Compare the two.

Sally Remaley told me the Bradenton Herald requested the two AP releases Jim told me about - one with Jim and the other with Condon. All they got was the Condon statement that they had completed their investigation and would complete the report
