 Subject: Indexes for certain Commission Documents

October 14, 1968

Many of the large FBI reports submitted to the Warren Commission and filed as Commission Documents (CD's) include indexes. We have obtained all such available indexes and are making them available to other researchers.

Each index, prepared by the FBI, lists almost all of the proper names in the CD, as well as telephone and license plate numbers, and the like. They are a useful supplement to other indexes, and to the Commission's "name files" of "other individuals and organizations involved or interviewed," which contains some material from the many CD's without indexes but which are not at all complete. Researchers without ready access to the Archives can use these 47 indexes for, in effect, browsing through the 14,000 pages they cover. In addition, by listing all the index references to a given page, one can deduce quite a bit about the parts of these CD's which are still withheld from research. (If you would like to help us prepare a study of the withheld pages, please let me know.)

You may obtain all 47 available unpublished indexes from us on microfilm for \$ 10. (Please specify positive or negative.) A Xerox copy is available for \$ 25 total (238 pages, with 4 pages of the original photographically reduced onto 1 page; Archives price for a Xerox copy of this material would be about \$ 180), or 11¢ per page for selected indexes. The indexes, with the number of (reduced image) pages in each, are listed here:
