Dallas, March 10 (AP)- Mrs. Targuerite Oswald, mother of Lee Harvey Oswald who was accused of slaying President Kennedy, appeared at Jack Ruby's murder trial today and was promptly served a subpoenax to testify for the prosecution.

The prosecution's swift action took Oswald's mother by surprise and angered her.

"I asked to be a spectator," she said. "Now I've been subpoenaed.
"My dander is up. This is what I don't like. I don't like being

pushed."

She was visibly angry and appeared at one point on the verge of tears.

Mrs. Oswald, 56, declined repeatedly answer newsmen's direct question, but at one point exclaimed:

"I believe Lee Harvey oswald should be in this comptroom and having a trial of his own."

She declared she had the "courage and guts" to stand up for her slamm son .

She would not reply to questions concerning Ruby, who burst through a crowd Nov. 24 and shot "swald before nationwide television cameras.

Mrs. Oswald said, "I'm going to stay in Dallas for the rest of this trial."

She was sworn in as a witness moments after court convened.

Mrs. swald then was excorted utside the courtroom to a bench.

Above it were the signs: "witnesses only" and "do not talk to witnesses."

Asst.Dist. Atty A.D. Jim Bowie said the state feared that an outburst from Mrs. swald in front of the jury could constitue a reversible error, thereby forcing the court to re-start the trial from the beginning, including selection of jurors.

Before the surprise subpoena, Mrs. oswald told newsmen, "I have thought this over thoroughly and I have now decided to attend the trial. I think this will satisfy me as a mother. This really should be Lee's trial, and my presence there may give me just some little new clue."

Mrs. Oswald, who maintains that her som is innocent, also said:
"I am working, investigating this case, not as a mother, but as a person interested in justice."

She flew to Dallas from New York last night. Home home is in Fort Worth, Tex. mw932acs
