MARTIN SAID THAT HE AND ATTORNEY JOHN THORNE OF GRAND PRAIRIE HAVE A CONTRACT WHICH MRS. OSWALD IS SEEKING TO BREAK.

"IT NEARLY ALWAYS HAPPENS ON A PERSONAL MANAGEMENT CONTRACT THAT WHEN THE MONEY STARTS COMING N THE CLIENT WANTS OUT OF THE CONTRACT," MARTIN SAID, "AND THAT IS WHAT HAS HAPPENED IN THE CASE OF MRS. OSWALD."
