NIGHT LEAD MARINA (270) BY

DALLAS JUNE 10 (AP)-LEE HARVEY OSWALD'S WIDOW, MARINA, LOOKING MUCH LIKE A PRETTY MODEL, FLEW TO WASHINGTON TODAY FOR A SECOND APPEARANCE BEFORE THE WARREN COMMISSION.

MARINA, WHOSE HUSBAND WAS CHARGED WITH KILLING PRESIDENT JOHN F. KENNEDY LAST NOV.22, TESTIFIED IN FEBRUARY BEFORE THE COMMISSION, NEARING THE END OF AN INVESTIGATION OF THE ASSASSINATION.

IT WAS BELIEVED THE COMMISSION WOULD QUIZ THE SLENDER RUSSIAN-BORN MOTHER OF TWO THIS TIME ON DETAILS PRESENTED IN SUBSEQUENT TESTIMONY BEFORE THE PANEL.

MARINA, HER REDDISH HAIR SWELLED IN A BOUFFANT STYLE, WORE A NEATLY FITTING BLACK SUIT, WITH TAN LEATHER GLOVES AND SHOES.

SHE WAS SMILING, BUT DONNED DARK GLASSES AS SHE STEPPED INTO BRILLIANT SUNLIGHT TO BOARD AN EASTBOUND JET. SHE MADE NO COMMENT, MOVING QUICKLY PAST NEWSMEN AND PHOTOGRAPHERS.

HER PLANE WAS EXPECTED IN BALTIMORE AT 9:37 P.M. (AED).

ACCOMPANYING MARINA WERE HER SISTER-IN-LAW, MRS. ROBERT OSWALD, AND HER NEW LAWYER, WILLIAM A. MCKENZIE. HER OLDEST DAUGHTER, JUNE, 2, HAD BEEN SCHEDULED TO MAKE THE TRIP BUT WAS NOT ALONG.

ROBERT OSWALD IS THE BROTHER OF THE ACCUSED ASSASSIN, WHO WAS SHOT NOV.24 BY JACK RUBY DURING A JAIL TRANSFER.

MARINA SAID IN AN INTERVIEW YESTERDAY SHE DID NOT KNOW WHY SHE WAS BEING RECALLED BEFORE THE COMMISSION, BUT SHE SAID "I WANT TO HELP THEM ALL I CAN."

MARINA SAID SHE HOPED TO SEE WASHINGTON SIGHTS, INCLUDING THE SMITHSONIAN INSTITUTION, AND "SPEND A LITTLE QUIET TIME" AT THE NATION'S CAPITAL.

MCKENZIE, CHOSEN IN FEBRUARY TO REPRESENT MARINA, SAID A COURT SETTLEMENT STILL IS PENDING WITH TWO MEN THE PETITE WIDOW CONTRACTED LAST DECEMBER TO HANDLE HER LEGAL AND BUSINESS AFFAIRS.

AT THE TIME, PUBLIC SYMPATHY HAD BROUGHT AN OUTPOURING OF CONTRIBUTIONS. THE AMOUNT OF DONATIONS HAS CONTINUED TO SWELL TO MORE THAN \$65,000.

SHE SAYS SHE STILL RECEIVES LETTERS FROM THE AMERICAN PEOPLE, MANY FROM MEN OFFERING MARRIAGE.
