

Oswald Widow Sues U.S.

DALLAS, Tex. (AP)—Mrs. Marina N. Oswald Porter, the widow of the man the Warren Commission named as the assassin of President John F. Kennedy, has sued the U.S. government for \$500,000 as compensation for the government's seizure of Lee Harvey Oswald's personal effects. Mrs. Porter listed more than 300 items, ranging from hunting knives to a billfold to shirts and sweaters, as having belong to Oswald at the time of his death.

U.S. SUED BY WIDOW FOR OSWALD ITEMS

DALLAS, Oct. 30 (AP)—Mrs. Marina N. Oswald Porter, the widow of the man the Warren Commission named as President Kennedy's assassin, has sued the United States Government for \$500,000 as compensation for the Government's seizure of Lee Harvey Oswald's personal effects. Mrs. Porter listed more than 300 items, ranging from hunt-

ing knives to a billfold to shirt and sweaters, as having belonged to Oswald at the time of his death. "The value of these items then and now is \$500,000," she said in an action filed Friday in the Federal District Court in Dallas. "The United States Attorney General has taken all right, title and interest in these items." Mrs. Porter, a native of the Soviet Union, was married to Kenneth Jess Porter June 1, 1965.

DALLAS, Tex. AP - The U.S. government has been sued for \$500,000 by Marina N. Oswald Porter, the widow of the man named by the Warren Commission as the assassin of President John F. Kennedy.

Mrs. Porter, in a action filed in U.S. District Court here, asks the \$500,000 as compensation for the government's seizure of Oswald's personal effects.

She listed more than 300 items, ranging from hunting knives to shirts and sweaters, as having belonged to Oswald at the time of his death. The petition stated "the U.S. attorney general has taken all right, title and interest in these items."

Oswald's personal effects were to be stored in the National Archives, according to a special law passed to that effect.

WHITE PLAINS, N.Y. AP - The late Tommy Manville's wife No. 9 sued in Westchester County Surrogate's Court Monday to try to keep wife No. 11 from inheriting the asbestos heir's estimated \$20million-plus estate.

No. 9, Anita Roddy-Eden, claims that her 1955 divorce from the millionaire playboy was invalid. She asked the court to award her a widow's share in the estate.

Manville, who died earlier this month, left everything to his last wife, No. 11, former waitress Christina Erdlen Manville.

Miss Roddy-Eden contended that Manville's will and two codicils were not properly executed, not signed before attesting witnesses and were "procured by fraud, duress and undue influence." She added that Manville "was not mentally competent to make a will".

NEW YORK AP - Frank J. Hines has a creek running through his Long Island property and he built a bridge over it that kept boats from navigating downstream to Great South Bay. "It's my water and my land," said Hines, "and I didn't want anyone going through it."

Neighbors had complained that the 35-foot long wooden span was a "spite bridge" across Mud Creek in East Patchogue.

The jury found Hines guilty Monday of illegally building a bridge across a navigable waterway. The 58-year-old builder and developer who contended it wasn't navigable, faces a maximum sentence Dec. 1 of a year in prison and a \$2,500 fine. He must also tear down the bridge.

SAN JOSE, Calif. AP - San Jose State College, which had to cancel a football game last month during campus racial troubles will have a Negro homecoming queen Saturday for its game with the University of Wyoming.

She is Valerie Dickerson, 20, one of about 100 Negroes in a student body of 22,000. She was elected in a campuswide vote last weekend.

Miss Dickerson, whose 35-20-35 figure must have helped her campaign, is outspoken on racial matters. She once addressed a joint session of the Montana Legislature on the subject while a student at Carroll College, Helena, Mont.
