'Q' a Year Later--Where Is

A year later the question

Where is Stephen Bingham? And is he dead or alive?

If he's dead, who killed him - the authorities or "the revolution" - and why?

If he's alive, where is he and who's hiding him?

The FBI and the Marin County District Attorney's office admit frankly they don't know the answers to any of those questions.

But they're assuming he's still alive and they're still looking for him.

6 Slain

Bingham, 30 year old scion of an influential political family in Connecticut, is wanted for his alleged smuggling of a pistol into San Quentin to inmate George Jackson, then considered by the radical left to be a "hero of the revolution."

Jackson, two other inmates and three prison guards were slain in the bloody escapade - described by prison authorities as an abortive escape attempt and termed by many radicals a set-up to kill Jackson. It took place at the prison a year ago tomorrow.

Two days after that, Marin County District Attorney Bruce Bales said he wanted to talk to Bingham, an attorney involved in a variety of radical causes. There was no response.

Murder Charge

On Aug. 31, Bingham was charged with five counts of murders. A sweeping manhunt since has failed to trace him, and some authorities believe he is dead the theory being he was shut up to erase evidence of the elaborate escape plot.


Bingham's father, attor-

ney Alfred M. Bingham of Salem, Conn., noted that his son had vanished without a trace hours after the San Quentin bloodshed and suggested he might have met with foul play.

'Live Case'

But the FBI, the California Attorney General's office and Marin authorities are reluctant to agree with that conclusion. They are treating Bingham as a "live case."

FBI spokesman said, "We have the case under active investigation and are still

pursuing all possible leads. We are going on the assumption Bingham is still alive." Bingham had been "sight-ed" in Wisconsin, Boston and abroad, but none of the leads checked out.

State and local officials say they are bound by a court-ordered gag rule and will not discuss the case except in the most general
