BALLAS, APRIL 25 (AP)-POLICE CHIEF JESS CURRY SAYS DALLAS POLICE OFFICERS WILL TAKE LIE DETECTOR TESTS IF ANY TESTIMONY THEY GAVE THE WARREN COMMISSION IS DOUBTED.

CURRY'S STATEMENT CAME YESTERDAY AFTER DALLAS POLICE LT. JACK REVILL CONFIRMED HE REPORTED TO HIS SUPERIORS NOV. 22 THAT AN FBI AGENT SAID OF LEE HARVEY OSWAL: "WE KNEW HE WAS CAPABLE OF ASSASSINATING THE PRESIDENT.

REVILL WAS REPORTED TO HAVE TESTIFIED BEFORE THE WARREN COMMISSION WHAT HE SAID HE HEARD FROM FBI SPECIAL AGENT JAMES (JOE) HOSTY.

FBI DIRECTOR J. EDGAR HOOVER SAID IN WASHINGTON "THE AGENT WADE NO SUCH STATEMENT AND THE FBI DID NOT HAVE SUCH KNOWLEDGE.

REVILL SAID HE WROTE A MEMO TO HIS SUPERIORS STATING THAT HOSTY HAD MADE THE REMARKS SOON AFTER OSWALD WAS CAPTURED IN A THEATER FOLLOWING PRESIDENT KENNEDY'S ASSASSINATION.

"HE WAS EXCITED." REVILL SAID. "EVERYBODY WAS EXCITED, AND HE PROBABLY SAID THINGS HE SHOULDN'T HAVE.

THE DALLAS OFFICER ADDED: "I HAD ONE OF MY MEN WITH ME WHO CAN CONFIRM WHAT HOSTY SAID.

REVILL. WHO HEADS THE CRIMINAL INTELLIGENCE SECTION OF THE POLICE SPECIAL SERVICE BUREAU, APPEARED BEFORE THE COMMISSION INVESTIGATING THE ASSASSINATION SEVERAL WEEKS AGO IN DALLAS.

CURRY APPEARED BEFORE THE PRESIDENTIAL BODY IN WASHINGTON THIS WEEK. CURRY ALSO SAIDS

- "IN KEEPING WITH THE POLICY THAT HAS BEEN FOLLOWED BY THE CITY OF DALLAS, ALL INFORMATION WE HAVE CONCERNING ALL PRASES OF THE ASSASSINA-TION AND SUBSEQUENT EVENTS HAS BEEN TURNED OVER TO THE WARREN COMMISSION. WHAT IS RELEASED WILL BE RELEASED BY THE WARREN COMMISSION."

THE POLICE CHIEF ADDEDS

"IF ANY OF OUR REPORTS ARE QUESTIONED BY THE COMMISSION, OUR OFFICERS HAVE INDICATED A WILLINGNESS TO SUBMIT TO POLYGRAPH EXAMINATIONS TO VERIFY THEIR STATEMENTS."

V. J. BRIAN WAS THE OTHER OFFICER REVILL SAID WAS WITH HIM AT THE TIME OF THE FBI AGENT'S ALLEGED STATEMENT. BRIAN HAS NOT YET APPEARED BEFORE THE COMMISSION.
