Executive privilege - At the end of statement by Nixon on domestic intelligence plans (see above) he says, "Executive privilege will not be invoked as to any testimony concerning possible criminal conduct or discussions of possible criminal conduct, including the Watergate affair and the alleged coverup."

Lydon: "President Nixon abandoned today his once adamant insistence that 'executive privilege' should keep his personal staff from having to testify before Congress about the Watergate scandal. A single sentence near the end of his long statement today [paragraph above] means that Mr. Nixon's present and former aides will not be able to refuse to appear and answer questions in the Senate Watergate hearings on the ground that White House communications have an inherent Presidential privacy. Only weeks ago, President Nixon saw executive privilege as a virtually absolute power to deny White House information and staff to Congress."

Mrs. Nixon "seems to be weathering the Watergate storm well. But there was a period when she was so tense that former First Lady Mamie Eisenhower expressed concern to mutual friends . . . " (Complete.)

- B-"Events indicate that many of Huston's recommendations were carried out: The essence survived without its label. On June 27th, 1973, John Dean told the Ervin Committee he had never seen any document to indicate the president had disapproved or rescinded the Huston Plan. On July 9th, 1973, Huston told a closed House Armed Services intelligence subcommittee hearing, the plan was never formally cancelled. These include the listing of the agency chief [Bernard Wells] under an entirely different title [chief of the non-classified Inter-Departmental Information Unit] and division within the Justice Department. According to the investigators, the order to 'hide' the existence of the agency was given by Robert C. Mardian Mr. Mardian has been identified in news reports as the Justice Department's liaison officer with the White House 'plumbers' group which was set up in June, 1971. " Unnamed Justice Department spokesman "questioned" the assertion that the order came from Mardian, saying "Mardian didn't give orders like that. The Attorney General [Mitchell; probably concurred in the fact that this be held secret." Same official did confirm the misleading listing.
