Dean's expected testimony about Nixon-Dean conversation
21 Mar 73 (Hunt "blackmail"). Nixon: " ... if we could pre-empt that one, we've got him right by the balls."

It is difficult to determine at what point in the conversation Nixon made this remark; Lardner does not say and the transcript itself is not given. Apparently at the beginning of the conversation (from context) Nixon says, "The one thing which, of course, is a sticky point, is with regard to the 21st and if you'd give some thought with regard to how you could pre-empt that sometime, uh, I think it would be very good . . . I don't know how the hell you can, but uh, . . . " Haldeman: "I think we can somehow, and I think . . . " Nixon: "Somehow just put it out, you know?" Haldeman: "I had a couple of ideas on that." Haldeman goes on to say he doesn't have with him the notes he made today on his ideas, but when he wrote them out they

There is no explanation of Nixon's phrase "put it out."

Lardner says Haldeman spent some time at the EOB today reviewing his WH files on Watergate and that Nixon "spent hours [today] reviewing some of his still-secret tapes."

Dean was to have testified before Ervin committee 19 Jun 73 but this was postponed to 25 Jun, due to Brezhnev visit to U.S. 18 to 25 Jun.

Butterfield, in intw with Ervin committee staff 13 Jul, tells them of WH taping system; testifies in public session 16 Jul.

Haldeman testifies 31 Jul about listening to tapes of two Nixon-Dean meetings, 15 Sep 72 and 21 Mar 73; says that some of the things Dean said were discussed on 13 Mar actually were discussed on the 21st, when Nixon, after saying there would be no problem in raising a million dollars, went on to say, "but it would be wrong." According to WH transcript of this conversation (released by Nixon 30 Apr 74 when he gave 48 transcripts to House Judiciary Committee), the remark about a million dollars appears on page 25 of the transcript (p. 194 of WH volume). His statement, "It is wrong that's for sure" does not appear until page 38 (p. 207 of WH volume); it deals with Dean clemency (not money) for Hunt, and Nixon/wex Zuretting xing paires that clemency would be wrong from a political standpoint.
