~~Summary~~ According to summary, Dean says Hunt would talk only to Colson about Hunt's future. After Dean received a message from Hunt* in which Hunt asked for ~~\$2~~ \$72,000 for living expenses and \$50,000 for lawyers' fees or he would tell of some of the things he had done for Ehrlichman while Hunt was at the White House, Ehrlichman told Dean to call Mitchell. Nixon knew of ~~this~~ Hunt's threat and demand for money*** On 21 or 22 Mar Ehrlichman asked Mitchell if Hunt's problem had been taken care of, and Mitchell said, "Yes." **
