Nixon refuses to release tape recordings to Ervin committee and Cox. In letter to Ervin says, "the tapes are entirely consistent with what I know to be the truth and what I have stated to be the truth." "None has been transcribed or made*

In separate letter to Ervin says "no useful purpose" will be served by meeting with him (see 12 Jul); is willing to go through with a meeting if Ervin insists, but Ervin says he will not.

SFC [NYT] 24 Jul 73 *public and none will be."

Ervin signs wrong subpoena (repartedly due to maurical error on the part of a committee staff meror member) which orders Nixon to appear before committee 24 Jul; second subpoena is also wrong; third version calls only for production of tapes and documents.

Tapes - Buzhardt is served with subpoena by Cox; Garment is served with two subpoenas by Ervin committee. Letter from Cox to Buzhardt lists tapes of the conversations he wants.

Cox subpoena calls for tapes; Ervin committee subpoenascall for tapes and "other documents." *

Cox - Richardson, testifying before Senate Judiciary Committee 8 Nov 73, and consulting notes he took during a phone conversation with Haig, quotes Haig as saying, "The President wants a tight line drawn . . . and no further mistakes . . . or we'll get rid of Cox." (See entry 8 Nov 73.)

Bernard Kalb (CBS, State Dep't) says (no date) his office has been illegally entered and, on one occasion, ransacked. (See entry 9 July, on earlier intrusion.)

Kalb says that today he again found evidence that his office had been entered. AP: "However, department officials said janitors may have left the office in disarray. [Rogers] called Kalb to apologize and express concern over the two incidents. State Department officials said no evidence has been turned up concerning the incident. [Kalb] said nothing appeared to be missing."
