Haldeman, in testimony at Ervin hearings 31 Jul, says this was the day he informed ~~him~~ the White House through his lawyers ~~that~~ of his intention to tell the committee he had listened to two White House tapes, those of 15 Sep 72 and 21 Mar 73 of Nixon-Dean meetings.

"Asked whether the President had spent any of the weekend on Watergate-related matters, the spokesman replied, 'I don't believe he has.'"

Today is a Sunday. Have no indication when Nixon went to Camp David.
