Agnew holds televised press conference, denouces as lies reports that he took kickbacks from contractors in Maryland; says that last February he first heard rumors the investigation might involve him, early in April retained lawyer, Judah Best, and sent him (no date) to U.S. Atty in Baltimore, George Beall, to tell him he would not attempt to impede the investigation; was formally notified 2 Aug 73 that he was under investigation.

From NYTimes story by : "The broader impression of Agnew's half-hour appearance was an apparently self-conscious contrast with Mr. Nixon's sustained isolation from the press since the Watergate scandal broke around the White House."

Warren issues statement for Nixon saying the fact that Agnew is under investigation by is "no reason for the

President to change his attitude about the vice president or his confidence in the vice president."

Nixon issues statement expressing confidence in Agnew before flying to Camp David (today is a Wednesday), ENXHERT Leaves White House an hour after Agnew completes his press conference; was in his office during the news conference but did not watch it.

Agnew - WXPost 8 Aug carries two stories with interesting details on investigation of Angew. Investigation began in Jan 73, at which time Beall was assuring Justice Dep't officials that whatever its outcome, Agnew could not be involved (statute of limitations?), but during May and June the emphasis began to shift to Agnew. (Beall app. by N, 1970.)

Christopher Lydon says Nixon "reportedly tried to prevent" Agnew press conference. During the press conference Agnew said he would "stand on his own feet." Lydon says, "A senior White House advisor commented immediately, 'Well, if he thinks he has to stand on his own two feet, we'll just let him.'"
